THE CONTRIBUTORS

W. Arthur Lewis, Professor of Political Economy at the University of Manchester, is currently on leave of absence, serving as Economic Adviser to the Prime Minister of Ghana, under UN Technical Assistance. His publications include *Principles of Economic Planning* (new ed., 1952) and *The Theory of Economic Growth* (1955).

GEORGE W. RATHJENS, JR., has been a member of the Weapons Systems Evaluation Group in the Office of the Secretary of Defense since 1953, and of the Institute for Defense Analyses in the Pentagon since its incorporation.

C. M. Woodhouse became Director of the Royal Institute of International Affairs in 1955 and its Director of Studies in 1956. In recent years, he has served in the Foreign Office and has been a Fellow of Trinity Hall at Cambridge and Visiting Fellow of Nuffield College at Oxford.

Lincoln Gordon is William Ziegler Professor of International Economic Relations in the Graduate School of Business Administration at Harvard. He acted as consultant to the North Atlantic Council's Committee of Three Ministers on Nonmilitary Cooperation in NATO in 1956, and edited *International Stability and Progress: United States Interests and Instruments*, published by the American Assembly in June 1957.

EDWARD SHILS is Professor in the Committee on Social Thought and the Department of Sociology at the University of Chicago. The author of *The Torment of Secrecy: The Background and Consequence of American Security Policies* (1956), he is at work on three studies: Love, Belief and Civility, The Indian Intellectual, and Self-Government and Public Liberties in the New Countries, the last-named under the auspices of the Congress for Cultural Freedom.

ADDA B. BOZEMAN has been Professor of Political Science at Sarah Lawrence College since 1947. A member of the Columbia Faculty Seminar on Peace, she has recently completed a manuscript entitled *Image and Reality in International History: A Commentary on International and Intercultural Relations*.

WILLIAM EBENSTEIN is Professor of Politics and Faculty Associate of the Center of International Studies at Princeton University. Among his publications are Modern Political Thought (1954) and Today's Isms: Communism, Fascism, Capitalism, Socialism (2nd ed., 1958).

Otto Kirchheimer joined the Graduate Faculty of the New School for Social Research in New York as Professor of Political Science in 1955. On leave during the current academic year on a Rockefeller fellowship, he is engaged in studying interrelations between politics and the administration of justice.

- G. H. MATTERSDORFF, having served on the staff of the Intra-European Trade Section of ECA in Washington and in the Office of the Special Representative of ECA in Paris, is now Instructor of Economics at Connecticut College.
- S. T. Beza is Assistant Professor of Economics and Research Associate in the International Finance Section at Princeton University.

WILLIAM C. Olson has been Assistant Professor of Government and Chairman of the Committee on International Relations at Pomona College since 1953. He is preparing a book of readings in the theory of international relations with David McLellan and will be Director of a Danforth Summer Seminar on "International Economic Policy and Human Values," to be held in Claremont, Calif., in June 1958.
