THE CONTRIBUTORS

SAMUEL P. HUNTINGTON is Frank G. Thomson Professor of Government and Associate Director of the Center for International Affairs at Harvard University. He is editor of the quarterly journal, Foreign Policy. His recent books include Political Order in Changing Societies (1968) and, as co-editor, Authoritarian Politics in Modern Society: The Dynamics of Established One-Party Systems (1970). He is currently investigating the impact of external factors on the political and economic development of nation-states.

THEODORE H. MORAN is Assistant Professor of Political Science at Vanderbilt University. His forthcoming book is entitled El Cobre es Chileno—The Multinational Corporation and the Politics of Development: The Case of Copper in Chile, 1945-1972. He is currently working at formulating and testing hypotheses on the political economy of international dependence.

ANNA P. SCHREIBER, formerly Assistant Professor of Political Science at Rutgers University, is now with the Mobil Oil Corporation as International Public Affairs Advisor. She is the author of *The Inter-American Commission on Human Rights* (1970), and is currently preparing a comparison of the status of women in the United States and Scandinavia.

DAVID GRANICK is Professor of Economics at the University of Wisconsin. He is the author of Soviet Metal-Fabricating and Economic Development: Practice vs. Policy (1967) and Managerial Comparisons of Four Developed Countries: France, Britain, United States, and Russia (1972). At present he is completing an interview-based study of comparisons of industrial management among selected Socialist countries with centralized and decentralized economies.

TOM J. FARER is Professor of Law at the Rutgers School of Law (Camden). He is the author of *The Law of War Twenty-five Years After Nuremberg* (1971). Currently he is engaged in a study of UN sanctions against Rhodesia, part of a project organized by the Royal Institute of International Affairs.

RICHARD SANDBROOK is Assistant Professor of Political Science at the University of Toronto. He has recently completed a book on organized labor in Kenya.
