#### T.S. Ashton Prize

The T.S. Ashton Prize, established with funds given by the late Professor T.S. Ashton, is awarded for an essay by a young scholar (under the age of thirty-five at the time of submission) on any subject within the general field of economic and social history.

The prize is £ 150 and will be awarded every two years. The prize essay will be published in the *Economic History Review*.

The essay must be a work of original research, not hitherto published, and one which has not been awarded any other prize. It must not exceed 8,000 words in length. Anyone intending to submit work for consideration for the prize should first obtain details of the conditions of entry from the Editors, *Economic History Review*, School of Economic and Social Studies, University of East Anglia, Norwich, NR4 7TJ. Entries for the 1987-1988 prize can be submitted at any time up to 1 January 1989.

### E.S.R.C. Research Grants

The British Economic and Social Research Council (formerly the Social Science Research Council) is interested in receiving applications for grants in support of research projects in economic and social history. Grants are made to U.K. universities, colleges, or established non-profit research institutes but not to individuals. Applicants not on the staff of one of these may apply provided one such institution sponsors the application. Not only large-scale projects are supported: requests for modest sums are equally welcome.

Applications for under £ 30,000 may be submitted at any time. Closing dates for larger sums and for Personal Research Grants are 15 January and 15 August. Copies of the (omnibus) Research Proposal form and the explanatory booklet are available from all U.K. university and polytechnic registrar's departments or from the E.S.R.C. (160 Great Portland Street, London W1).

Intending applicants are invited to seek advice from the secretariat of the E.S.R.C. Committee to which the topic of the project seems most relevant.

### Berkshire Prizes

The Berkshire Conference of Women Historians will award its annual prizes for the best book and the best article on any historical subject written by an American woman and published during 1987. ### Linz Conference

Since 1965 international conferences on the history of the workers' movement have been held at Linz (Austria). The last one was from 8 to 11 September 1987; the participants included researchers from Asia, Africa, America and Europe.

The Austrian Ministry of Science and Research has now decided to drastically reduce the annual subsidy for the conferences, from 90.000 Schilling to 40.000 Schilling. Representatives of institutes and organizations from 25 countries have protested against this measure in a resolution which was carried unanimously. They point out that the 'Linz Conference' has world-wide fame and "has won an increasing measure of support in Third World countries, matched by hardly any other institute in Austria." The resolution asks the Minister "to maintain the already relatively low state subsidy at the 1986 level, in view of the exceptionally economic management of our research community." Despite these problems preparations for the next Linz Conference (September 1988) are going ahead as usual. There will be two themes on the agenda: (i) the formation of the working class (during the first phase of industrialization) and (ii) the workers' movement and ecology. ### **IALHI**

The International Association of Labour History Institutions (IALHI), which recently held its eighteenth annual meeting in Bonn, has become an important international meeting point for archives, museums and research institutes specializing in labour history. Affiliated to it are almost 100 institutes from Australia, Brazil, Canada, Israel, Japan, USA, Venezuela and fifteen West European countries. The 1989 annual meeting will be held in Amsterdam, at the International Institute of Social History.

## Popular Education in Giolitti's Italy

#### War Enthusiasm
