THE VARIATIONAL THEORY OF HIGHER-ORDER LINEAR DIFFERENTIAL EQUATIONS

YASUO TERANISHI

§1. Introduction

In his paper [2], [3], D. A. Hejhal investigated the variational theory of linear polynomic functions. In this paper we are concerned with the variational theory of higher-order differential equations. To be more precise, consider a compact Riemann surface having genus g > 1. As is well known, we can choose a projective coordinate covering $\mathfrak{A} = (U_a, z_a)$. Fix this coordinate covering of X. We shall be concerned with linear ordinary differential operators of order n defined in each projective coordinate open set U_a

$$(1.1) L_{n,a}(P_a|z_a) = \left(\frac{d}{dz_a}\right)^n + \sum_{\ell=1}^n \binom{n}{\ell} P_{n,a}(z_a) \left(\frac{d}{dz_a}\right)^{n-\ell}$$

where coefficients $P_{1,a}(z_{\alpha}), \dots, p_{n,a}(z_{\alpha})$ are holomorphic in U_{α} . Differential operators $\{L_{n,a}(P_{\alpha}|z_{\alpha})\}$ are called a semi-canonical form if $P_{1,a}(z_{\alpha})=0$ for all α .

Let $\lambda \in H^1(X, \mathcal{O}_x)$ be a complex line bundle on X. Differential operators $\{L_{n,\alpha}(P_\alpha|z_\alpha)\}$ are called λ -related if in each intersection $U_\alpha \cap U_\beta$

$$(1.2) L_{n,\alpha}(P_{\alpha}|z_{\alpha})y = \left(\frac{dz_{\beta}}{dz_{\alpha}}\right)^{n} \lambda_{\alpha\beta}(z)^{-1} L_{n,\beta}(P_{\beta}|z_{\beta}) \lambda_{\alpha\beta}(z_{\beta})y.$$

We shall prove an analogous theorem of the Laguerre-Forsyth's basic differential invariants.

Theorem 1.1. Let $\{L_{n,a}(P_a|z_a)\}\$ be a λ -related semi-canonical form, then

$$(\theta_{m,a}(z_a)) \in \boldsymbol{\varGamma}(\mathfrak{A},\,\mathscr{O}(\kappa^m)) \qquad (m=2,\,3,\,\cdots,\,n)$$

where $\theta_{m,a}(z_a)$ is holomorphic function in U_a defined by:

Conversely for given $\theta_m(z) \in \Gamma(\mathfrak{A}, \mathcal{O}(\kappa^m))$ $(m = 2, 3, \dots, n)$, we can define differential polynomials of $\{\theta_m(z)\}$

$$P_{2,a}(z_a)$$
, $P_{3,a}(z_a)$, \cdots , $P_{n,a}(z_a)$.

And differential operators $\{L_{n,a}(P_a|z_a)\}$ are a λ -related semi-canonical form.

If $\varphi_{1,a}(z_a), \dots, \varphi_{n,a}(z_a)$ are n linearly independent holomorphic solutions of the λ -related semi-canonical differential equation $L_{n,a}(P_a|z_a)y=0$ and σ is any element of SL(n, C) then the vector valued holomorphic function $\varphi_a(z_a) = {}^t(\varphi_{1,a}(z_a), \dots, \varphi_{n,a}(z_a))$ satisfies in each intersection $U_a \cap U_\beta$

(1.3)
$$\varphi_{\alpha}(z_{\alpha}) = \rho_{\alpha\beta}(c_{\alpha\beta}z_{\beta} + d_{\alpha\beta})^{1-n}\varphi_{\beta}(z_{\beta})$$

for some $\rho_{\alpha\beta} \in SL(n, C)$, and the composition $\varphi'_{\alpha} = \sigma \circ \varphi_{\alpha}$ satisfies a relation of the form (1.1) with $\rho_{\alpha\beta}$ replaced by $\rho'_{\alpha\beta} = \sigma \circ \rho_{\alpha\beta} \circ \sigma^{-1}$. Therefore the mapping φ_{α} and φ'_{α} are considered as describing equivalent flat vector bundles of rank n on X.

There is a natural one to one correspondence between the cohomology set $H^1(X, SL(n, C))$ and the quotient space $\operatorname{Hom}(\pi_1(X), SL(n, C)/SL(n, C), \operatorname{SL}(n, C))$ where SL(n, C) acts on $\operatorname{Hom}(\pi_1(X), SL(n, C))$ by inner automorphisms. The homomorphism obtained from a λ -related semi-canonical equation is called a monodromy representation. The fundamental group $\pi_1(X)$ is described canonically as a group with 2g generators $\sigma_1, \dots, \sigma_g, \tau_1, \dots, \tau_g$ and the commutator relation $[\sigma_1, \tau_1] \dots [\sigma_g, \tau_g] = 1$.

Introducing the complex variety

$$(1.4) N = \{(X_1, \dots, X_g, Y_1, \dots, Y_g) \in SL(n, C)^{2g} | [X_1, Y_1] \dots [X_g, Y_g] = 1\},$$

the mapping which associates to an element $\rho \in \text{Hom}(\pi_1(X), SL(n, C))$ the point $(\rho(\sigma_1), \dots, \rho(\sigma_g), \rho(\tau_1), \dots, \rho(\tau_g)) \in N$ identifies $\text{Hom}(\pi_1(X), SL(n, C))$ with the complex analytic variety N and the cohomology set $H^1(X, SL(n, C))$ with the quotient space V = N/SL(n, C) where SL(n, C) acts on N by inner automorphisms. (See Gunning [5]). The tangent space to the variety V at a point corresponding to the monodromy representation ρ of a λ -related semi-canonical differential equation is identified with the cohomology group $H^1(\pi_1(X), \operatorname{Ad}_0 \rho)$ of the group $\pi_1(X)$ with coefficients in the space of $n \times n$ matrices of trace zero under the group representation $\operatorname{Ad} \rho$.

By Theorem 1.1, we can introduce a complex analytic mapping between the vector space $\bigoplus_{m=2}^{n} \Gamma(X, \mathcal{O}(\kappa^{m}))$ and the variety N, and the tangent

space to the image at a monodromy representation $\rho \in N$ is identified with the space of the period classes of the Prym differentials $\Gamma(X, \mathcal{O}^{1,0}(\mathrm{Ad_0} \, \rho))$. We shall introduce the transvectants which are known in the classical invariant theory and using them describe the period classes of the Prym differentials (The variational formula).

The formulas also suggest a close relationship with Eichler cohomology groups. Many formulas in this paper can be found in Hejhal ([2], [3]) under the restriction $2 \le n \le 6$ and we shall eliminate this restriction using invariant theoretic method.

§2. The basic differential equations and the monodromy representation

Let X be a compact Riemann surface of genus g>1. Since the genus of X is greater than one, as is well known we can find a coordinate covering $\mathfrak{A}=\{(U_a,z_a)\}$ such that the coordinate transformations of this coordinate covering are projective linear transformations

$$(2.1) \hspace{1cm} z_{\scriptscriptstyle\alpha} = \frac{a_{\scriptscriptstyle\alpha\beta}z_{\scriptscriptstyle\beta} + b_{\scriptscriptstyle\alpha\beta}}{c_{\scriptscriptstyle\alpha\beta}z_{\scriptscriptstyle\beta} + d_{\scriptscriptstyle\alpha\beta}} \hspace{0.2cm} \begin{pmatrix} a_{\scriptscriptstyle\alpha\beta} & b_{\scriptscriptstyle\alpha\beta} \\ c_{\scriptscriptstyle\alpha\beta} & d_{\scriptscriptstyle\alpha\beta} \end{pmatrix} \in SL(2,\,C) \hspace{0.2cm} \text{in} \hspace{0.2cm} U_{\scriptscriptstyle\alpha} \cap U_{\scriptscriptstyle\beta} \,.$$

Such a coordinate covering $\mathfrak A$ is called a projective coordinate covering of X.

We denote by $L_{\alpha}(n)$ the set of all the homogeneous monic linear differential operators of degree n defined in a projective coordinate open set U_{α} :

$$(2.2) L_{n,a}(P_{\alpha}|z_{\alpha}) = \left(\frac{d}{dz_{\alpha}}\right)^n + \sum_{\ell=1}^n \binom{n}{\ell} P_{\ell,a}(z_{\alpha}) \left(\frac{d}{dz_{\alpha}}\right)^{n-\ell}$$

where coefficients $P_{1,a}(z_a), \dots, P_{n,a}(z_a)$ are holomorphic on U_a and $\binom{n}{\ell}$ is the binomial coefficient.

We denote by $L_n(P|z)$ the collection of local differential operators:

$$(2.3) Ln(P|z) = (Ln,a(Pa|za)),$$

and denote by $\mathcal{L}(n)$ the set of all $L_n(P|z)$.

For a given complex line bundle $\lambda \in H^1(X, \mathcal{O}^{\times})$, we associate an element $L_n(P|z) \in L(n)$ which satisfies the following transformation relation in $U_a \cap U_{\beta}$

$$(2.4) L_{n,\alpha}(P_{\alpha}|z_{\alpha})y = \left(\frac{dz_{\beta}}{dz_{\alpha}}\right)^{n} \lambda_{\alpha\beta}(z_{\beta})^{-1} L_{n,\beta}(P_{\beta}|z_{\beta}) \lambda_{\alpha\beta}(z_{\beta})y.$$

Definition 2.1. Differential operators $L_n(P|z)$ satisfying the relation (2.4) is called a λ -related differential operator.

Definition 2.2. Differential operators $L_n(P|z) \in L(n)$ is called a semi-canonical form if $P_{1,\alpha}(z_\alpha) = 0$ for all α .

Lemma 2.1. Let $\lambda \in H^1(X, \mathcal{O}^{\times})$ be a complex line bundle on X, and $L_n(P|z)$ be a λ -related differential operator. Then

$$(2.5) P_{1,a}(z_a) = \left(\frac{dz_a}{dz_\beta}\right)^{-1} \left\{ P_{1,\beta}(z_\beta) + \lambda_{\alpha\beta}^{-1}(z_\beta) \frac{d}{dz_\beta} \lambda_{\alpha\beta}(z_\beta) + \frac{n-1}{2} \left(\frac{dz_a}{dz_s}\right)^{-1} \left(\frac{d}{dz_s}\right)^2 z_a \right\}.$$

For the proof, see ([1], Lemma 3.5).

PROPOSITION 2.1. Let $\lambda \in H^1(X, \mathcal{O}^{\times})$ be a complex line bundle on X, and $L_n(P|z)$ be a λ -related semi-canonical form. Then

$$(\lambda) = (n-1)(g-1)$$
.

Proof. From Lemma 2.1, $\lambda_{\alpha\beta}$ satisfies the differential equation

The solutions of this equation are given by

$$\lambda_{lphaeta}(z_{eta}) = rac{e_{lphaeta}}{(dz_{lpha}/dz_{eta})^{n-1/2}} \qquad (e_{lphaeta}\in C) \ .$$

Since the transition function of the canonical line bundle is defined by

$$\kappa_{lphaeta}(z_{eta})=\left(rac{dz_{lpha}}{dz_{eta}}

$$\deg \kappa_{\alpha\beta} = 2(g-1),$$

it follows that

$$\deg(\lambda_{\alpha\beta}) = (n-1)(g-1)$$
. Q.E.D.

We shall now prove an analogous theorem of the Laguerre-Forsyth's basic differential invariants.

Theorem 2.1. Let $\mathfrak{A} = (U_a, z_a)$ be a projective coordinate covering of X, $\lambda \in H^1(X, \mathcal{O}^\times)$ be a complex line bundle of X, and let $L_n(P|z)$ be a λ -related semi-canonical form. In each projective coordinate open set U_a we introduce holomorphic functions $\theta_{m,a}(z_a)$ $(m=2,3,\dots,n)$ by:

(2.6)
$$\theta_{m,\alpha}(z_{\alpha}) = \frac{1}{2} \sum_{k=0}^{m-2} (-1)^{k} \frac{(m-2)! \, m! \, (2m-k-2)!}{(m-k-1)! \, (m-k)! \, (2m-3)! \, k!} \times \left(\frac{d}{dz_{\alpha}}\right)^{k} P_{m-k,\alpha}(z_{\alpha}).$$

Then

$$(\theta_{m,a}(z_a)) \in \boldsymbol{\Gamma}(\mathfrak{A}, \mathcal{O}(\kappa^m))$$

where κ is the canonical line bundle of X.

Conversely if local holomorphic functions $\theta_{m,\alpha}(z_{\alpha})$ represent an element of $\Gamma(X, \mathcal{O}(\kappa^m))$ $(m = 2, 3, \dots, n)$, then there is a complex line bundle $\lambda \in H^1(X, \mathcal{O}^{\times})$ and, if we put

$$(2.7) P_{\ell,a}(z_a) = \sum_{m=2}^{\ell} {\ell \choose m} \frac{(\ell-1)! (2m-1)!}{(m-1)! (m+\ell-1)!} \left(\frac{d}{dz_a}\right)^{\ell-m} \theta_{m,a}(z_a) ,$$

the semi-canonical form $L_n(P|z)$ defined in each projective coordinate open set U_a by

$$(2.8) L_{n,\alpha}(P_{\alpha}|\pmb{z}_{\alpha}) = \left(\frac{d}{d\pmb{z}_{\alpha}}\right)^n + \sum_{\ell=2}^n \binom{n}{\ell} P_{\ell,\alpha}(\pmb{z}_{\alpha}) \left(\frac{d}{d\pmb{z}_{\alpha}}\right)^{n-\ell}$$

is a λ -related semi-canonical form.

To prove Theorem 2.1, we need some lemmas

Lemma 2.2. Let $\begin{pmatrix} a & b \\ c & d \end{pmatrix} \in SL(2, \mathbb{C})$, then we have;

Proof. For the proof of (ii), see ([1] Lemma 1.12).

Let us prove by (i) by induction on m. It is obvious for m = 0. Assume (i) for m and let us prove (i) for m + 1. Since ad - bc = 1

LEMMA 2.3. Let X be a compact Riemann surface of genus g > 1, let $\mathfrak{A} = \{U_a, z_a\}$ be a projective coordinate covering of X such that the transition functions are given by

and let $\lambda \in H^1(X, \mathcal{O}^{\times})$ be a complex line bundle on X. Then linear differential operators $L_n(P|z)$ is a λ -related semi-canonical form if and only if coefficients $\{P_{m,\alpha}(z_a)\}$ satisfy in each $U_a \cap U_\beta$

(2.11)
$$P_{2,\beta}(z_{\beta}) = (c_{\alpha\beta}z_{\beta} + d_{\alpha\beta})^{-4}P_{2,\alpha}(z_{\alpha})$$

and for $m = 3, 4, \dots, n$,

Proof. $L_n(P|z)$ is a λ^{n-1} -related semi-canonical form if and only if in each $U_{\alpha}\cap U_{\beta}$

Since $a_{\alpha\beta}d_{\alpha\beta}-b_{\alpha\beta}c_{\alpha\beta}=1$, we have

and by Proposition 2.1,

$$\lambda_{\alpha\beta}(z_{\beta}) = (c_{\alpha\beta}z_{\beta} + d_{\alpha\beta})^{n-1}e_{\alpha\beta},$$

where $e_{\alpha\beta}$ is a complex number.

By virtue of Lemma 2.2, we have

Comparing the coefficient of $(d/dz_{\beta})^{\ell}y$, we obtain the desired result.

Q.E.D.

Lemma 2.4. Let F(z) be any polynomial whose degree is less than n. Then

Proof. For a non negative integer m less than n, we introduce the polynomial $F_m(z)$ by

Since $F_m(1) = 0$, it follows that

$$\sum_{\ell=0}^{n} (-1)^{\ell} \binom{n}{\ell} \ell (\ell-1) \cdots (\ell-m+1) = 0.$$

We can now conclude (2.13) by induction on the degree of F(z). Q.E.D.

3. The transvectant

In this paragraph we shall introduce differential operators called the ransvectants. The transvectant is the one of basic methods to create ew covariants from given covariants and is known since 19-th century n the classical invariant theory, we shall now generalize the classical ransvectants.

Let $\mathfrak{A} = (U_a, z_a)$ be a projective coordinate covering of a Riemann urface X such that the coordinate transition functions are given by

§4. The Eichler cohomology groups

We shall review some basic facts and definitions about Eichler cohomology groups associated to the given projective structure on the Riemann surface X. Let $\mathfrak{A} = \{U_a, z_a\}$ be a projective coordinate covering of X such that the coordinate transition functions are given by

If $p \in U_{\alpha}$ is a point of X and $f \in \mathcal{O}(\lambda^{-n})_p$ is a germ of section at p, then f is represented by a holomorphic function $f_{\alpha}(z_{\alpha})$, and in $U_{\alpha} \cap U_{\beta}$ $\{f_{\alpha}(z_{\alpha})\}$ are related by

By Proposition 3.1, we have an exact sequence of sheaves

where $\Gamma(-)^*$ stands for the dual vector space to $\Gamma(-)$. The groups $H^1(X, P_n(\lambda^{-n}))$ are the Eichler cohomology groups of the Riemann surface X.

§ 5. The monodromy representations

We shall investigate flat vector bundles coming from monodromy representations of the fundamental group of X.

Let $\{\varphi_a(z_a)\}$ be the holomorphic vector functions satisfying (2.16) in $U_a \cap U_\beta$, and denote the Wronskian matrix of $\varphi_a(z_a)$ by $F_a(z_a)$:

We shall introduce local coordinate $\{\dots, t_i^{(2)}, \dots, t_j^{(3)}, \dots, t_k^{(n)}, \dots\}$ at the point $(\theta_2(z), \dots, \theta_n(z))$ in $\bigoplus_{m=2}^n \Gamma(X, \mathcal{O}(\kappa^m))$ by

ho_{lphaeta}^{-1})G_{lpha}(z_{lpha})\,-\,G_{eta}(z_{eta}))arphi_{eta})(z_{eta})\,.$$

This completes the proof.

Q.E.D.

We shall investigate the differential equation (5.11) in a small neighborhood of the origin in the parameter space t (see (5.6)).

Lemma 5.5. Let X(z), Y(z) be vector valued functions defined as follows

$$X(z) = \left[egin{array}{c} dots \ z^{(n-1-a)} \ dots \end{array}
ight], \qquad Y(z) = \left[(-1)^a z^{(a)} \ dots \end{array}
ight]$$

where $a = 0, 1, 2, \dots, n-1$ and $z^{(a)} = z^a/a!$.

We introduce the $n \times n$ matrix valued function $M_{n(m)}(z)$ by

$$M_{n,m}(z) = \langle X(z), Y(z) \rangle^{n-m}$$

where \langle , \rangle^{n-m} stands for the n-m-th transvectant.

Then we obtain;

- (1) the maximum degree of components in $M_{n,m}(z)$ is equal to 2(m-1)
- (2) $\operatorname{Tr}(M_{n,i}(z), M_{n,k}(w)) = c_k \delta_{ik}(z-w)^{2(k-1)}$

where δ_{ik} is the Kronecker delta and c_k is a non zero rational constant dependent sololy on (i, n).

Proof. From definition the following properties hold

$$(i) X \left(rac{az+b}{cz+d}
ight) = (cz+d)^{1-n} A_{\sigma} X(z)$$

(ii)
$$Y \begin{pmatrix} az + b \\ cz + d \end{pmatrix} = (cz + d)^{1-n} {}^{t}A_{\sigma}^{-1}Y(z)$$

where $\sigma = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in SL(2, \mathbb{C})$ and $\sigma \to A_{\sigma}$ is the *n*-th symmetric representation of $SL(2, \mathbb{C})$.

By virtue of Proposition 3.1. we have

$$M_{n,m}\left(rac{az+b}{cz+d}
ight)=(cz+d)^{-2(m-1)}\mathrm{Ad}\left(A_{\sigma}\right)M_{n,m}(z)$$
.

In particular, putting $\sigma_1=\begin{pmatrix}1&p\\0&1\end{pmatrix}$ $(p\in C),\ \sigma_2=\begin{pmatrix}0&1\\-1&0\end{pmatrix}$ we have

$$(5.20) M_{n,m}(z+p) = A_{\sigma_1} M_{n,m}(z) A_{\sigma_1}^{-1}$$

and

(5.21)
$$M_{n,m}(-1/z) = z^{-2(m-1)}A_{\sigma_2}M(z)A_{\sigma_2}^{-1}.$$

It follows from (5.20) that the maximum degree d of components in the matrix $M_{n,m}(z)$ is not greater than 2(m-1). If d < 2(m-1), again by (5.20) we have $M_{n,m}(0) = 0$. Since a straightforward computation shows that the (n, n-m+1) component in the matrix $M_{n,m}(z)$ is not zero, the maximum degree of components in the matrix $M_{n,m}(z)$ is equal to 2(m-1). From (5.20), (5.21), for any non zero complex numbers z, w we have

$$\begin{split} &\operatorname{Tr}\left(M_{n,\,i}(z),\,M_{n,\,k}(w)\right) = \operatorname{Tr}\left(M_{n,\,i}(z-w),\,M_{n,\,k}(0)\right).\\ &\operatorname{Tr}\left(M_{n,\,i}(-1/z),\,M_{n,\,k}(-1/w)\right) = z^{-(m-1)}w^{-2(k-1)}\operatorname{Tr}\left(M_{n,\,i}(z),\,M_{n,\,k}(w)\right)\\ &\operatorname{Tr}\left(M_{n,\,i}\left(\frac{w-z}{zw}\right),\,\,M_{n,\,k}(0)\right) = \operatorname{Tr}\left(M_{n,\,i}(-1/z),\,M_{n,\,k}(-1/w)\right). \end{split}$$

Hence we conclude;

$$\operatorname{Tr}(M_{n,i}(z), M_{n,k}(w)) = c_k \delta_{ik}(z-w)^{2(k-1)}$$

where c_k is a constant.

We shall show that the constant c_k is not zero.

By a direct computation the (p, q) component $M_{n,m}(z)$ in the matrix $M_{n,m}(z)$ is given as follows,

$$egin{aligned} M_{n,m}(z)_{p,q} &= \sum\limits_{\ell=m}^{n}{(-1)^{\ell-m}inom{n}{\ell}inom{\ell}{m}} \ &\cdot rac{(\ell-1)!\,(2m-1)!}{(m-1)!\,(m+\ell-1)!}inom{\ell+q-p-1}{q-1}igg) z^{(m+q-p-1)} \end{aligned}$$

where we denote for any integer ℓ

$$z^{(\ell)} = egin{cases} rac{z^\ell}{\ell!} & \ell > 0 \ 0 & \ell \leqq 0 \end{cases}.$$

Since the degree of the (p, q) component in the matrix $M_{n,m}(z)$ is m-1 if and only if p=q, the coefficient of $2^{m-1}w^{m-1}$ in the polynomial $\operatorname{Tr}(M_{n,m}(z), M_{n,m}(w))$ of 2 variables z, w is equal to

$${\textstyle\sum\limits_{p=1}^{n} \left(\sum\limits_{\ell=m}^{n} {(-1)^{\ell-m} \binom{n}{\ell} \binom{\ell}{m}} \frac{(\ell-1)! \ (2m-1)}{(m-1)! \ (m+\ell-1)!} \binom{\ell-1}{p-1} \right)^{2}}.$$

Since

$$\begin{split} &\sum_{\ell=m}^{n} (-1)^{\ell-m} \binom{n}{\ell} \binom{\ell}{m} \frac{(\ell-1)! (2m-1)!}{(m-1)! (m+\ell-1)!} \\ &= \binom{n}{m} \frac{(2m-1)!}{(m-1)!} \sum_{\ell=0}^{n-m} (-1)^{\ell} \binom{n-m}{\ell} \frac{1}{(\ell+m)(\ell+m+1)\cdots(\ell+2m-1)} \\ &= \binom{n}{m} \frac{(2m-1)!}{(m-1)!} \frac{(n-1)!}{(n+m-1)!} \end{split}$$

the coefficient of $z^{m-1}w^{m-1}$ in the polynomial $\mathrm{Tr}\left(M_{n,\,m}(z),\,M_{n,\,m}(w)\right)$ is not zero. This means that the constant c_k is not zero. Q.E.D.

Let us introduce vector valued holomorphic functions $X_a(z_a)$, $Y_a(z_a)$, $M_{n,m,a}(z_a)$ in each projective coordinate open set (U_a, z_a) by

$$X_a(z_a) = X(z_a), \quad Y_a(z_a) = Y(z_a) \quad \text{and} \quad M_{n,m,a}(z_a) = M_{n,m}(z_a).$$

Then $\{X_{\alpha}(z_{\alpha})\}$ correspond to semi-canonical form

$$L_{n,\,lpha}(p_{\,lpha}|\,z_{\,lpha})=\left(rac{d}{dz_{\,lpha}}
ight)^{n}$$

and $Y_a(z_a) = X_a^*(z_a)$.

By virtue of Proposition 5.1 for any element $\theta_{m,\alpha}(z_{\alpha}) \in \Gamma(\mathfrak{A}, \mathcal{O}(\kappa^m))$,

$$(5.22) (M_{n,m,a}(z_a)\theta_{m,a}(z_a)) \in \boldsymbol{\Gamma}(\mathfrak{A}, \operatorname{Ad}_0 \rho)$$

and

(5.23)
$$\operatorname{Tr}(M_{n,m,\alpha}(z_{\alpha}), M_{n,\ell,\alpha}(w_{\alpha})) = c_{m}\delta_{m,\ell}(z_{\alpha} - w_{\alpha})^{2(m-1)}.$$

DEFINITION 5.3. The *C*-linear mapping β_m from the complex vector space of holomorphic *m*-differentials $\Gamma(X, \mathcal{O}(\kappa^m))$ to the vector space $\Gamma(X, \mathcal{O}^{1,0}(\mathrm{Ad}_0 \rho))/d\Gamma(X, \mathcal{O}(\mathrm{Ad}_0 \rho))$ is defined by

$$\beta_m: \quad \boldsymbol{\varGamma}(X,\,\mathscr{O}(\kappa^m)) \longrightarrow \boldsymbol{\varGamma}(X,\,\mathscr{O}^{1,\,0}(\mathrm{Ad}_0\,\rho))/d\boldsymbol{\varGamma}(X,\,\mathscr{O}(\mathrm{Ad}_0\,\rho)) \\ \{\theta_{m,\,\alpha}(\boldsymbol{z}_\alpha)\} \longmapsto \{M_{n,\,m,\,\alpha}(\boldsymbol{z}_\alpha)\theta_{m,\,\alpha}(\boldsymbol{z}_\alpha)\}/\mathrm{mod}\;d\boldsymbol{\varGamma}(X,\,\mathscr{O}(\mathrm{Ad}_0\,\rho))\;.$$

Theorem 5.2. Let θ be the complex analytic mapping defined by (5.19);

$$\theta : \bigoplus_{m=2}^{n} \Gamma(X, \mathcal{O}(\kappa^{m})) \longrightarrow V$$

and let ρ be the n-th symmetric tensor representation of the fundamental group $\pi_1(X)$. Then the mapping θ is non-singular at the origin $(0, \dots, 0) \in \bigoplus \boldsymbol{\Gamma}(X, \mathcal{O}(\kappa^m))$ and the tangent space to the image at the point $\rho \in V$ can be identified with the (n^2-1) (g-1)-dimensional subspace of $H^1(X, \operatorname{Ad}_0 \rho)$ consisting of the period classes of the Prym differentials $\boldsymbol{\Gamma}(X, \mathcal{O}^{1,0}(\operatorname{Ad}_0 \rho))$.

Proof. By virtue of Lemma 5.1 and Theorem 5.1, the tangent vector

$$\rho_{lphaeta}(t)^{-1}rac{\partial}{\partial t} \rho_{lphaeta}(t)|_{t=0}\in H^1(X,\,(\mathrm{Ad}_0\,
ho))$$

is equal to the period class of the Prym differential $\{M_{n,m}(z_{\alpha})\theta_{m,\alpha}(z_{\alpha})\}$ up to a non-zero constant. By (5.23) and recalling $\{\theta_{mj,\alpha}\}(1 \leq j \leq \dim \boldsymbol{\Gamma}(X,\mathcal{O}(\kappa^m))\}$ is a basis of $\boldsymbol{\Gamma}(X,\mathcal{O}(\kappa^m))$, we can conclude that the image in $H^1(X,\operatorname{Ad}_0\rho)$ of the mapping on the tangent space induced by the mapping $\theta: \oplus \boldsymbol{\Gamma}(X,\mathcal{O}(\kappa^m)) \to V$ is the space of period classes of the Prym differentials $\boldsymbol{\Gamma}(X,\mathcal{O}^{1,0}(\operatorname{Ad}_0\rho))$. Since it follows from the Riemann-Roch theorem that

$$\dim \bigoplus_{m=2}^{n} \boldsymbol{\Gamma}(X, \mathcal{O}(\kappa^{m})) = (n^{2}-1)(g-1)$$

and

$$\dim \boldsymbol{\varGamma}(X, \mathcal{O}^{1,0}(\mathrm{Ad}_0 \,\rho))/d\boldsymbol{\varGamma}(X, \mathcal{O}(\mathrm{Ad}_0 \,\rho)) = (n^2 - 1)(g - 1) \,,$$

the mapping θ is non-singular. This completes the proof. Q.E.D.

By Theorem 5.2, the mapping

$$\oplus \ \beta_m \colon \oplus \boldsymbol{\varGamma}(X, \, \mathscr{O}(\kappa^m)) \longrightarrow \frac{\boldsymbol{\varGamma}(X, \, \mathscr{O}^{1, \, 0}(\mathrm{Ad}_0 \, \rho))}{d\boldsymbol{\varGamma}(X, \, \mathscr{O}(\mathrm{Ad}_0 \, \rho))}$$

is an isomorphism. Hence the following diagram holds:

$$0 \longrightarrow \bigoplus_{m=2}^{n} \boldsymbol{\varGamma}(X, \mathcal{O}(\kappa^{m})) \longrightarrow \bigoplus H^{1}(X, P_{2(m-1)}(\kappa^{-(m-1)})) \longrightarrow \bigoplus \boldsymbol{\varGamma}(X, \mathcal{O}(\kappa^{m}))^{*} \longrightarrow 0$$

$$0 \longrightarrow \frac{\boldsymbol{\varGamma}(X, \mathcal{O}^{1,0}(\operatorname{Ad}_{0}\rho)}{d\boldsymbol{\varGamma}(X, \mathcal{O}(\operatorname{Ad}_{0}\rho))} \longrightarrow H^{1}(X, \operatorname{Ad}_{0}\rho) \longrightarrow \left[\frac{\boldsymbol{\varGamma}(X, \mathcal{O}^{1,0}(\operatorname{Ad}_{0}\rho))}{d\boldsymbol{\varGamma}(X, \mathcal{O}(\operatorname{Ad}_{0}\rho))}\right]^{*} \longrightarrow 0$$

where lows sequences are exact and []* stands for the dual vector space. Hence two vector spaces $\bigoplus H^1(X, P_{2(m-1)}(\kappa^{-1}))$ and $H^1(X, \operatorname{Ad}_0 \rho)$ are canonically isomorphic. (See [4], [6])
