**JOHN L. HAMMOND** is the author of *Building Popular Power: Workers' and Neighborhood Movements in the Portuguese Revolution*. He teaches sociology at Hunter College and the Graduate Center, City University of New York, and is writing a book on popular education and the guerrilla war in El Salvador.

Founder of the Latin American Jewish Studies Association, **JUDITH LAIKIN ELKIN** is a research associate at the Frankel Center for Judaic Studies at the University of Michigan. Her most recent book is *Latin American Jewish Studies: An Annotated Guide to the Literature*, coauthored with Ana Lya Sater.
