



The South China Sea Arbitration

A Chinese Perspective

Edited by Stefan Talmon and Bing Bing Jia

This book aims to offer a Chinese perspective on some of the issues raised in the arbitral proceedings of the South China Sea dispute between the Republic of the Philippines and the People's Republic of China. On 19 February 2013, the PRC formally expressed its opposition to the institution of proceedings, making it clear from the outset that it will not have any part in these arbitral proceedings and that this position will not change. It is thus to be expected that over the next year and a half, the Tribunal will receive written memorials and hear oral submissions from the Philippines only. The Chinese position will go unheard. This book aims to offer a (not the) Chinese perspective on some of the issues to be decided by the Tribunal and thus to assist the Tribunal in meeting its obligations under the Convention. The book does not set out the official position of the Chinese government, but is rather to serve as a kind of amicus curiae brief advancing possible legal arguments on behalf of the absent respondent.

Stefan Talmon is Professor of Public Law, Public International Law and European Union Law, and Director of the Institute for Public International Law at the University of Bonn.





Students in the clinic have worked on cases before the International Criminal Court, Special Tribunal for Lebanon, the Extraordinary Chambers in the Courts of Cambodia and the International Criminal Tribunal for Rwanda. Sixteen students have held externships at these Tribunals; one served as a fellow. Students have represented survivors of forced labor and commercial sex trafficking; drafted amicus briefs applying international law to issues such as the Armenian genocide and juvenile life without parole sentencing; and, publicized human rights issues through a variety of events.

The Center is conveniently located at the Society's headquarters and is open to everyone interested in learning more about international arbitration and conciliation.




