Abortion and Buddhism in Japan

William R. LaFleur

Why would a country strongly influenced by Buddhism's reverence for life allow legalized, widely used abortion? In this provocative investigation, William LaFleur examines abortion as a window on the culture and ethics of Japan. At the same time he explores how the Japanese resolve their conflicting emotions privately and avoid the pro-life/pro-choice politics that sharply divide Americans.

The author explains how reproduction and religion became contested in nineteenth-century Japan, when highly politicized religious movements condemned abortion and urged women to have as many children as possible. Tracing the troubled history behind the eventual consensus that has allowed legalized abortion since 1948, he describes the emergence of a society that values the family in rhetoric and in practice.

Six Circles, One Dewdrop

The Religio-Aesthetic World of Komparu Zenchiku

Arthur H. Thornhill III

Arthur Thornhill presents the first major study in English of the dramaturgical treatises of Komparu Zenchiku (1405-1468?), son-in-law and pupil of the illustrious Zeami and a pivotal figure in the history of Japanese noh drama.

The book begins with annotated translations of two of Zenchiku's most important treatises, which delineate a system of seven symbolic categories called "six circles and one dewdrop." Especially significant are two commentaries appended to the first treatise and composed by the Buddhist prelate Shigyoku (1383-1463) and Ichijō Kaneyoshi (1402-1481), the renowned court official and scholar. Together Zenchiku's symbolic system and the two commentaries reveal a microcosm of the intellectual and cultural dialogue among the dominant creeds of the Muromachi period—Buddhism, Confucianism, and Shinto.

The editor welcomes preliminary inquiries about manuscripts for possible publication in *The Journal of Asian Studies*. Completed manuscripts should be sent to the editor, David D. Buck, *JAS*, Department of History, University of Wisconsin-Milwaukee, Milwaukee, WI 53201. Please submit four copies. All submitted work should be double-spaced, including extracts, notes, and references. Because manuscripts cannot be returned, please do not send the original. Consult recent issues of the *Journal* as a guide to the format for source citations, notes, and references. Footnotes should be as few as possible and typed double-spaced at the end of the text. Documentation should follow the style recommended in sections 15.4 through 15.35 of *The Chicago Manual of Style*, 13th ed. (Chicago: University of Chicago Press, 1982), pp. 400–408. All manuscripts submitted to the *JAS* are expected not to have been published elsewhere and not to be under review for possible publication elsewhere. Manuscripts, including notes, should not be more than 40 pages in length.

Authors are encouraged to submit tables, figures, and black-and-white photographs, and other illustrations along with their manuscripts. Photocopies or photos of record are acceptable for first review and should accompany the manuscript at original submission. Authors who wish to illustrate their articles with photographs must provide black-and-white glossy prints of good quality at the time of final delivery of their copyedited manuscript. Please provide a separate, typewritten, double-spaced list of captions and legends for all illustrations, keyed by number to each figure or photograph, including all necessary credit or permission lines. Authors are responsible for securing and paying for permission to use illustrative material. Do not write on the back of photographs or paste photographs to sheets of paper. Identify each photo by typing the first words of its caption on a stick-on label, then affix the label to the back of the photo. Photographs will be returned after publication.
