DAVID E. WHISNANT is Professor of English at the University of North Carolina. He also serves as Adjunct Professor of American Studies and belongs to the Core Faculty of the Curriculum in Folklore and to the advisory committee and teaching faculty of the Institute of Latin American Studies. He is currently completing a book on the politics of culture in Nicaragua.

JONATHAN ROSENBERG is a doctoral candidate in Political Science at the University of California, Los Angeles. He is currently Visiting Lecturer in Political Science at Whittier College and has recently begun a comparative study of policy responses to pressures for economic liberalization in Cuba and Mexico.

VIVIANE BRACHET-MARQUEZ is Professor of Sociology at El Colegio de México. She has published on the subject of the state and public policy in Mexico, especially on the welfare state. Her most recent book, *The Pact of Domination: State, Class, and Social Reform in Mexico (1910–1990)*, will soon be published by the University of Pittsburgh Press.

After completing a doctoral thesis at Cambridge University on the peasantry of northeastern Brazil, **JOHN R. HEATH** switched to studying Mexican agriculture, working at the Universidad Nacional Autónoma de México and the American University in Washington, D.C. He is now an agricultural economist at the World Bank, focusing on Francophone West Africa and having special responsibility for strategies dealing with interactions between agricultural development and the environment.

DONALD L. GIBBS is Latin American Studies Bibliographer at the University of Texas at Austin. His research and writing center on the Latin American book trade and publishing as well as on colonial Peruvian history.

ALISON BRYSK is Assistant Professor of Politics at Pomona College. Stanford University Press will publish her book, *The Politics of Human Rights: Symbolic Protest, Social Change, and Democratization in Argentina*. She is now researching the transnational alliances of indigenous rights movements in Latin America.

ROLLAND G. PAULSTON is Professor of Administrative and Policy Studies at the University of Pittsburgh. His research has focused on problems of social and education change (especially in Cuba, Peru, and Sweden) and on the problem of representing development knowledge and practice in our time.

VIRGINIA GIBBS is Assistant Professor of Spanish at Luther College in Decorah, Iowa. The author of *Las sonatas de Valle-Inclán: sensualidad, satanismo e historia* (1992), she is currently working on a book about the writings of Spanish explorers and pioneers in the Mississippi Valley and the Western United States.

JOHN D. MARTZ is Distinguished Professor of Political Science at the Pennsylvania State University. A former editor of *LARR*, he is currently editor of *Studies in Comparative International Development*. His ongoing research includes a book-length manuscript on political clientelism in Colombia.

JOHN FREDERICK SCHWALLER is Associate Dean and Professor of History and Languages of the Schmidt College of Arts and Humanities of Florida Atlantic University. He has written several books on the history of the secular clergy in early colonial Mexico. A new monograph on Mexico in 1600 should be ready for publication soon. His long-range research interest centers on the life and times of don Luis de Velasco, the younger.

SARAH CLINE has published a number of books on colonial Mexican Indians and is currently working on a history of the Catholic Church in Latin America.

RALPH LEE WOODWARD, JR., is Professor of History at Tulane University. Among his numerous books and articles are *Central America, A Nation Divided* (1985) and *Rafael Carrera and the Emergence of the Republic of Guatemala, 1821–1871* (1992). He also serves as the associate editor of *Scribner's Encyclopedia of Latin American History*.
