

Oral Tradition as History

Jan Vansina. *Oral Tradition*, published in 1961, was hailed internationally as a pioneering work in the field of ethno-history. Now, Jan Vansina—with the benefit of two decades of additional thought and research—has revised the original work substantially, completely rewriting some sections and adding much new material. The result is essentially a new work, indispensable to all students and scholars of history, anthropology, folklore, and ethno-history who are concerned with the transmission and potential uses of oral material.

VOLUME II: THE ELEPHANTS AND THE GRASS

John D. Hargreaves. This is the second and concluding volume of the author's thorough study of the partitioning of West Africa by European powers in the late nineteenth century. During the period 1890-98, the Europeans, under social and economic pressures from their homelands, finally gave up their attempts to modernize Africa peacefully and turned to the Maxim gun. The subtitle is adapted from an African folk-saying used to describe the period: "When elephants fight it is the grass that gets trampled!"

The Rise and Decline of the Zairian State

Crawford Young and Thomas Edwin Turner. In this broadly researched study, Young and Turner examine the political history of Mobutu's Zaire, looking at critical structures and patterns of societal flux, inequality, and cleavage, in particular the urban-rural nexus, the problematic of class formation, and the fluid patterns of cultural pluralism. Their thorough research and informed analysis will do much to illuminate the political workings of a major African state long considered an enigma by most Western observers.

Contributions to the *Journal* are welcomed. They may be submitted in either English or French. They should not exceed about 6000 words (excluding footnotes), except with the prior approval of the Editors. A summary of the contents of the article, not exceeding about 300 words in length, should be attached on a separate sheet. Contributors are asked to observe closely the conventions listed in the Notes for Contributors, Vol. XV, pp. 173-4. It is essential that contributors observe these conventions, as the *Journal* now goes straight into page proof. This severely limits the number of corrections which are possible.

Page proofs will be sent, if necessary by airmail, to each contributor (or his nominee) provided that the Editors have been given an address through which he can be reached without delay. Corrections should be kept to the minimum, and should be corrections, not new material. If they are to be incorporated in the master proof corrected by the Editors, it is important that the contributor should return the page proofs, by airmail if necessary, to the Editor named when they are sent out (and *not* to the Cambridge University Press), within ten days of his receipt of them.

Contributors of articles and review articles receive 25 free offprints. Additional offprints may be obtained at reasonable cost, provided that they are ordered before publication on the special form sent out with the page proofs.
