ICDD/CCDC Agreement Announced

The International Centre for Diffraction Data (ICDD) and the Cambridge Crystallographic Data Center (CCDC) are pleased to announce a cooperative program based on an *Extended Licence of Access Agreement*.

The agreement, which goes into effect immediately, allows the ICDD to calculate powder patterns for inclusion in the Powder Diffraction File (PDF), from defined portions of each data record in the Cambridge Structural Database (CSD). It is the intention eventually to include crosslinks in both the CSD and PDF, thus allowing users easy access to both databases. Individual database licences will be required where the intent is to use *both* the PDF and CSD. In addition to the benefits accruing from cross-referencing, we believe that useful new products will emerge from this cooperation.


