
Notes on Contributors

Christian Bailey is Assistant Professor of History at Purchase College, State University of New York. He completed his PhD at Yale University in 2009 before moving to the Max Planck Institute for Human Development, where he was a postdoctoral researcher with the History of Emotions group until 2011. Since then he has been lecturer in history at Balliol College, Oxford and at The Open University and Visiting Assistant Professor at Binghamton University in New York. His first book, *Between Yesterday and Tomorrow: German Visions of Europe, 1926–1950* (Berghahn Books, 2013) focused on German ideas for integrating Europe in the mid-twentieth century. He has since turned to the history of emotions, publishing on the history of honour in Britain and Germany, changing conceptions of emotions in European encyclopaedia since the eighteenth century and German concepts of emotions and civilisation during the age of high imperialism. He is currently writing a book on love between Jews and other Germans from the 1870s to the 1960s.

Rita Almeida de Carvalho is a postdoctoral fellow at the Institute of Social Sciences of the University of Lisbon. Her research interests include the interwar fascist and authoritarian regimes. She has written *A Condordata de Salazar* (Temas e Debates, 2013). She is currently working on transferences among fascist intellectuals.

Niamh Cullen is currently completing a book entitled *Love, Honour and Jealousy: Redefining Marriage in Italy, 1945–1970*, under review with Oxford University Press for their ‘Emotions in History’ series. Previous publications include *Piero Gobetti’s Turin: Modernity, Myth and Memory* (Peter Lang, 2012) as well as articles in *Modern Italy*, *Transnational Subjects*, *Journal of Modern Italian Studies* and *Cultural and Social History*. Recent articles on gender and sexuality in post-war Italy include: ‘Changing Emotional Landscapes? Grand Hotel and Representations of Love and Courtship in 1950s Italy’, *Social and Cultural History*, 11, 2 (2014), 285–306 and ‘Morals, Modern Identities and the Catholic woman: Fashion in *Famiglia Cristiana*, 1954–1968’. *Journal of Modern Italian Studies*, 18, 1 (2013), 33–52. A book chapter ‘Tuscan Subjectivities: Narrating Gender, Identity and Family in Rural Women’s Memoir from Fascism to

the Post-War Economic Boom' is also forthcoming in Silvia Ross and Claire Honess, eds., *Conflict and Identity in Tuscany* (Firenze University Press, 2015).

Marc Flandreau is Professor in the Department of International History at the Graduate Institute of International Studies and Development, Geneva. Flandreau has published extensively on monetary and financial history. He currently specialises in the history of the information economy, economic media and white collar criminality. Publications include *The Glitter of Gold. France, Bimetallism and the Emergence of the International Gold Standard* (Oxford University Press, 2004); 'The Economics of Badmouthing: Libel Law and the Underworld of the Financial Press in France Before World War I', *Journal of Economic History* (2011) (co-authored with Vincent Bignon) and a study of justificatory discourse after financial crises, 'The Vanishing Banker', *Journal of Financial History* (2012).

Norbert Götz is Professor at the Institute of Contemporary History, Södertörn University, Sweden. He is principal investigator of the research projects 'The Moral Economy of Global Civil Society: A History of Voluntary Food Aid' (Swedish Research Council) and 'Spaces of Expectation: Mental Mapping and Historical Imagination in the Baltic Sea and Mediterranean Region' (Foundation for Baltic and East European Studies). He is the author of *Deliberative Diplomacy: The Nordic Approach to Global Governance and Societal Representation at the United Nations* (Dordrecht, 2011) and has published articles on UN history in *Alternatives*, *Diplomacy and Statecraft*, *European Journal of International Relations*, *Journal of Cold War Studies* and *Scandinavian Journal of History*.

Emil Kerenji is Applied Research Scholar at the Jack, Joseph and Morton Mandel Center for Advanced Holocaust Studies at the United States Holocaust Memorial Museum in Washington. He has authored and collaborated on volumes in the Mandel Center's book series, *Jewish Responses to Persecution* (Rowman and Littlefield, 2010–5). He has also published articles, book chapters and book reviews in the fields of East European and Jewish history, as well as translations from Yiddish and into Serbian. He holds a Ph.D. in history from the University of Michigan.

Antonio Muñoz Sánchez has a Ph.D. from the European University Institute in Florence and works as a postdoctoral fellow at the Institute of Social Sciences in Lisbon. His research focuses on the relations between Iberia and Germany during the Cold War. He has published articles on migration and transnational party cooperation and two books, *El amigo alemán. El SPD y el PSOE de la dictadura a la democracia* (RBA Libros S.A., 2012) and *Von Franco-Diktatur zur Demokratie. Die Tätigkeit der Friedrich-Ebert-Stiftung in Spanien* (J.H.W. Dietz, 2013). Currently, he is carrying out research on Portuguese and Spanish forced workers in Germany during the Second World War, the West German military base in Beja (Portugal) and the involvement of the Friedrich Ebert Foundation in the Carnation Revolution.

James Robertson is Assistant Professor of Politics and History at Woodbury University. He completed his Ph.D. in Modern European History at New York University in 2014 and his BA in History and Philosophy at the University of Sydney.

Andrew Tompkins is a postdoctoral researcher at the Humboldt-Universität zu Berlin. His DPhil thesis will soon be appearing with Oxford University Press under the title *Better Active than Radioactive! Anti-Nuclear Protest in 1970s France and West Germany*. His current research project is focused on transnational relationships after the Second World War along the borders between France and West Germany on the one hand and Poland and East Germany on the other. From 2016 he will be a Lecturer in Modern History at the University of Sheffield.

Frédéric Zumer is Professor of Economics at the University of Paris II (Sorbonne Universités, Paris). An economist by profession and a historian by hobby, Zumer has co-authored with Marc Flandreau a monograph on market perceptions of government credit worthiness in the 19th century, *The Making of Global Finance 1880–1914* (OECD, 2004) and a study challenging popular assumptions about the effects of imperial domination on capital flows: ‘Black man’s burden, white man’s welfare: control, devolution and development in the British Empire, 1880–1914’, in *European Review of Economic History* (2010) (co-authored with Olivier Accominotti and Riad Rezzik).

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
