Theme:

### **Poverty and Child Abuse and Neglect**

*Children Australia* is calling for research, policy, practice interventions and legal papers that address the issue of Poverty and Child Abuse and Neglect. There is mounting international evidence that economic poverty and the resultant social disadvantage is a major factor influencing the incidence of abuse and neglect.

This issue will draw on national and international evidence to explore our understanding of the relationship between poverty and abuse and neglect, by asking the question - How should this relationship be addressed in casework practice and legal cases when child protection authorities institute care proceedings against parents who are living in poverty?

### **Deadline for manuscripts – 1 December 2019.**

June 2020.
