The basic premises and objectives reflected in the earlier editions of this book remain unchanged. It is the belief of the editors that considerable attention should be devoted to the study of fundamental values and persistent issues of our democracy in introductory courses in American Government. They have selected persuasively reasoned and authoritative statements for and against the issues under discussion and have included arguments by such great names as James Madison, Alexis de Tocqueville, and Oliver Wendell Holmes. The book encourages the student to analyze conflicting opinions, to re-examine the foundations of his beliefs, and to reach his own conclusions.

The volume may be adapted to the primary political science course or to one semester of an integrated social science course.
