**THE LEO GUZIK PRIZE IN JURISPRUDENCE
AND LEGAL HISTORY**

Mr. Leo Guzik, of New York, has established an annual prize of IL. 500.— for the best contribution in Jurisprudence or Legal History in the Israel Law Review or "Mishpatim" (Students Law Review). It will be available to students of the Hebrew University, Faculty of Law, working towards the degrees of LL.B., LL.M., or Dr. Jur. The award will be made by the Dean acting on the recommendation of an advisory committee comprising the Professors teaching Jurisprudence, Jewish Law, English Law, Roman Law and Ancient Near Eastern Law. The committee is not bound to make a recommendation. The award will not be made for a paper which has been awarded the George Webber Prize.
