Readers interested in putting together a Special Issue and acting as Guest Editors of the *Review of International Studies* should submit proposals by 1st April 2013 to ris@lse.ac.uk. Please note that Guest Editors will work alongside one of the members of the Editorial Team in developing the Special Issue.

Proposals relating to any sub-field of the discipline are welcome. We welcome new proposals as well as those submitted in the previous round that received positive feedback. Proposals should include the following information:

1. Name, affiliation and contact details of the proposed Guest Editor(s);
2. Names and contact details of the contributors;
3. Proposed title and theme of the Special Issue;
4. Background and Rationale for the proposal;
5. Detailed abstracts of all the papers.

All papers would need to be ready for a first round of peer assessment by the end of 2013. Please note that papers will be as closely peer reviewed as regular submissions to the journal.

The process of selecting the successful proposal will involve both independent referees and the Editorial Team. In making our selection, we will especially consider: the intellectual strength of the proposal; the interest of the topic to our readers; and the range and quality of the proposed contributions.
