DELIA M. BOYLAN is currently pursuing a Ph.D. in political science at Stanford University. Her work to date has focused on political economy issues confronting the developing world, including North-South economic relations and central bank reform.

MICHAEL R. CARTER is a professor in the Department of Agricultural Economics at the University of Wisconsin–Madison. His research examines the economic dynamics of class structure and agrarian transformation in Latin America and Africa, focusing on the way risk and capital markets shape—and misshape—these processes.

BRADFORD BARHAM, Assistant Professor in the Department of Agricultural Economics at the University of Wisconsin–Madison, is researching the effects of new technology, trade liberalization, and institution reform on the structure and performance of agriculture and natural-resource-based industries in Latin America and the United States.

A Ph.D. candidate in economics at the University of Oxford, **DINA MESBAH** is writing her dissertation on the economics of agrarian change.

LAIRD W. BERGAD teaches Latin American and Caribbean history at Lehman College and at the Graduate and University Center of the City University of New York. He recently coauthored *The Cuban Slave Market, 1790–1880*, with Fe Iglesias García and María del Carmen Barcia. He is currently working on a book manuscript on the demographic and economic history of slavery in Minas Gerais, Brazil.

GREG GRANDIN, a Ph.D. candidate in Latin American history at Yale University, is preparing a dissertation on the relationship between economic and ethnic transformation in nineteenth-century Guatemala.

RENE REEVES is completing a dissertation at the University of Wisconsin–Madison on community-state relations in the Mam region of the Guatemalan department of Quezaltenango during the nineteenth century.

DARIEN J. DAVIS teaches Latin American history at Middlebury College. He recently edited a collection of essays on the African contribution to Latin America and the Caribbean (published by Scholarly Resources). His current research focuses on nationalism and national identity in Latin America.

STUART B. SCHWARTZ, Professor of Latin American History at the University of Minnesota, published *Sugar Plantations in the Formation of Brazilian Society*, which won the Bolton Award. He is presently co-editing with Frank Salomon the volume on South America of the Cambridge History of Native American Peoples. His current research centers on the social and economic structures of the seventeenth-century Atlantic world and the effects of the separation of Spain and Portugal.

PATRICK CARROLL is Professor of History and Chair of the Humanities Department at Texas A & M University–Corpus Christi. He has published a book as well as several articles and essays on the black experience in colonial Latin America in general and Mexico in particular.

LAWRENCE E. PRESCOTT is Associate Professor of Spanish and African American Studies at the Pennsylvania State University. The author of *Candelario Obeso y la iniciación de la poesía negra en Colombia*, he has published several articles and reviews on Afro-Hispanic writers and criticism. He recently completed a book manuscript entitled "Without Hatreds or Fears: Jorge Artel and the Struggle for Black Literary Expression in Colombia."

Professor of History at Columbia University, **HERBERT S. KLEIN** has published numerous books and articles on Bolivia.

PAUL LAWRENCE HABER is Assistant Professor at the University of Montana. His recent publications have focused on political change in Durango, Mexico, and the political implications of Mexico's National Solidarity Program. He is currently working on a book on the politics of Mexican urban popular movements from 1979 to the present.

MARK T. GILDERHUS has taught history at Colorado State University since 1968 and has also done time as department chair. His interests center on U.S. relations with Latin America in the twentieth century.

DAVID KAIMOWITZ conducts research on tropical deforestation at the Center for International Forestry Research (CIFOR) in Jakarta, Indonesia. When he wrote this review essay, he was a specialist at the Inter-American Institute for Cooperation in Agriculture (IICA) in San José, Costa Rica.

SHELLEY A. MCCONNELL is Assistant Professor of Political Studies and Director of Latin American and Iberian Studies at Bard College. She is currently studying political development in Nicaragua under the Chamorro administration and the role of the United Nations in observing Nicaraguan elections in 1990.

DAVID L. BROWMAN is Professor of Anthropology at Washington University—St. Louis and chairs the combined program in Archaeology. His particular region of interest includes Bolivia and Peru, and his current research focuses on camelid pastoralism and the rise of complex civilizations in the altiplano.

STAN SHADLE, Assistant Professor of History at College Misericordia in Dallas, Pennsylvania, recently published *Andrés Molina Enríquez, Mexican Land Reformer of the Revolutionary Era* (1994).

JANET CATHERINE BERLO, Professor of Art History at the University of Missouri—St. Louis, has served as Acting Director of Pre-Columbian Studies at Dumbarton Oaks. She has also taught at the University of California, Los Angeles, and Yale University. She currently holds a Getty Senior Research Fellowship for 1994–1996.
