IMPORTANT ANNOUNCEMENT

With the appearance of Volume 7:1 in February of 1985, Studies in Second Language Acquisition will be published by Cambridge University Press. Production and distribution of the journal will emanate from the Press's New York offices, with editorial functions continuing to be directed from Indiana University. SSLA's editorial structure is to be substantially different. While Albert Valdman will remain as editor, he will be assisted by an active Editorial Board consisting of seven applied linguists from five different countries. Editorial policies are to be determined by the Editorial Board in consultation with a twelve-member Advisory Committee.

The scope of *SSLA* will remain unchanged, focusing on second language acquisition research construed broadly to encompass related fields such as language contact, bilingualism, language pathology, etc. Methodologically-oriented contributions will be considered to the extent that they address theoretical issues or are based on empirical research.

SSLA will retain its attractive red cover. The following changes, however, are being made to the journal. Three rather than two isues will be published within the course of a year; under the guidance of a guest editor, the second issue of each volume will be devoted to a particular topic pertinent to language acquisition. Upon publication of an issue, authors of articles, research notes, and review articles will receive 25 complimentary offprints. SSLA's new publication arrangement assures the journal wider dissemination and guarantees a regular publication schedule. In the course of the calendar year issues are scheduled to appear as follows: the first issue in February, the second in June, and the third in October.
