TELEVISION NEWS Archives

BIOLOGY and Social Life Section of Social Science Information

Roger D. Masters of Dartmouth College, the new chairman of Biology and Social Life section of SOCIAL SCIENCE INFORMATION, which is published under the auspices of the International Social Science Council, wishes to draw to the attention of interested scholars, the following statement of editorial policy of the section:

Research over the last two decades has revealed the vital importance of relationships between the biological and social sciences. Our understanding of human social organization and behavior is increasingly deepened and improved by consideration of the variables, propositions, and theoretical approaches of such life sciences as physiology, neurology, ethology, genetics, and ecology.

Throughout the social sciences, it is increasingly recognized that human social behavior and organization reflect the integration of processes, information, and explanatory variables at different levels of complexity. Since all living beings, including *Homo sapiens*, can be analyzed at the level of the species or gene pool, the social group or local population, and the individual organism as a complex system, the study of human social life can only be isolated from biological research at the risk of oversimplification. When simplistic reductionism is avoided, introduction of biological findings and approaches into the social sciences has already begun to provide valuable new insights in a wide variety of disciplines.

In recognition of the growing importance of co-disciplinary studies in the biological and social sciences, the "Animal and Human Ethology" section of *Social Science Information* is being expanded and renamed. To reflect more accurately the Section's objective of presenting articles in which current biological research is carefully integrated into the study of human behavior, its title has been changed to "Biology and Social Life."

While the Section will continue to meet the needs of social scientists for a better understanding of modern ethology, its methodology, and its relevance to human social processes, "Biology and Social Life" will welcome papers dealing with other aspects relating the biological to the social sciences. Particular emphasis will be placed on articles treating theoretical problems or research findings on the borderland of biology and such fields as social psychology, sociology,

political science, anthropology, and economics.

To reflect the international as well as interdisciplinary character of the section, the Editorial Board of "Biology and Social Life" is composed of representatives of a wide range of disciplines and nationalities:

An Imperial Russian Collection recently has been established at the Hoover Institution on War, Revolution and Peace at Stanford University, with Vasili Romanov, nephew of Czar Nicholas II and Prince of Russia, as honorary curator. World Association for PUBLIC OPINION Research

The World Association for Public Opinion Research is an inter-disciplinary international organization which seeks to establish a worldwide link between scientists working in the fields of survey research and applied social research. Its members come from many academic disciplines such as sociology, political science, economics, government and psychology. It is international as well as inter-disciplinary, with members from 26 countries.

The interests and activities of WAPOR's membership are varied; many come from universities, academic research centers, and governmental and non-governmental institutions; others come from commercial and international research centers.

Each year WAPOR organizes a congress. In the past these have been held jointly on alternative years with the American Association for Public Opinion Research (AAPOR) and the European Society for Opinion and Marketing Research (ESOMAR). Last year, at the WAPOR-ESOMAR Congress, WAPOR sponsored six ses-

sions. The theme of the WAPOR Congress was "Secondary Analysis of Sample Surveys: Uses and Needs." Sessions on "Education and Youth," "The Quality of Life," "Gallup and INRA," "Information and Communication," "Crime, Criminal Law, and Criminal Justice," and "Data Archives: Organizational, Research and Teaching Problems and Prospects" were held.

This year WAPOR sponsored sessions at the AAPOR Congress and is sponsoring two sessions at the International Sociological Association meetings. The sessions at the AAPOR Congress were "The Use of Survey Research by Policy Makers," "Social Indicators and the Quality of Life: International Developments," and an open methodological discussion on "Secondary Analysis," "Question Wording," "Research Design and Measurement," and "Improving Relations with Our Respondents." The sessions at the ISA meetings will be on "Public Opinion Research and Inter-disciplinarity," and "International Public Opinion Research: A Tool for Understanding Contemporary Societies."

In 1975, WAPOR will again hold a joint congress with ESOMAR. The meetings will be held from August 31 to September 4, 1975 in Montreux, Switzerland. The theme of the WAPOR part of the congress is "Planning for Change: Contributions of International Public Opinion Research." Sessions will be held on "The Contribution of Public Opinion Research to Politics and Constitutional Developments," "Education and Socialization Research: International Comparisons," "Survey Research and the Identification of Deprivation," "Survey Research and Economic Policy," "Survey Research in Developing Countries," "Measuring Change: Methodological Considerations," "Review of the Contribution of Survey Research to Policy—Governmental, Industrial, Commercial, and Social." In 1976 WAPOR will sponsor sessions at the AAPOR meetings. Negotiations are underway for a joint WAPOR-International Political Science Association Congress in the same year.

In addition to congresses, WAPOR offers its members a Newsletter which appears four times a year. This contains information on the association's activities and other information of interest to social scientists. Generally, at least one academic article is included in the Newsletter.

WAPOR also offers its members reduced subscriptions to *Public Opinion Quarterly*, *the International Social Science Journal*, and *Current Opinion* (a compendium of poll results published by the Roper Public Opinion Research Center, the world's largest survey archive). A mini-library of articles on and using secondary analysis has been compiled and is available for the use of members.

LONG BEACH Symposium

California State University, Long Beach, commemorated its 25th anniversary throughout the Fall Semester of 1974 by presenting a special symposium on The State of American Society. Designed in concept to bring closer the worlds of academic and public affairs, the program included four disciplines (political science, history, economics and law) with guest-participants Arthur M. Schlesinger, Jr., Leon H. Keyserling, Raoul Berger, Richard M. Scammon, Eugene McCarthy and Henry Steele Commager.

Each guest-participant, designated as University Fellow, spent two days in campus where he delivered a major address and took part in seminar-workshops with students enrolled in the symposium for academic credit. The program created a spirited sense of inter-action and exchange of ideas between the general community and students of the University concerning the issues of our times. A commemorative publication of symposium proceedings is to be issued shortly. Future programs of similar scope are planned by California State University, Long Beach, within areas of national concern.

LATIN AMERICAN Review

As a public service, the Institute of Latin American Studies in conjunction with the Communication Center—both of the University of Texas at Austin—are producing a series of 52, half-hour, weekly radio programs in English designed to keep radio listeners informed about the latest events in Latin America. Each week in the series the program brings to the audience a 15-minute up-to-date review of what the Latin American press is saying about both American and world events. Daily newspapers and journals of both fact and opinion from throughout Latin America are used in bringing to the radio listener the latest in economics, politics, and culture as seen through the eyes of the Latin American media. The second 15-minute portion of each weekly program is a special feature consisting of interviews in English with leading Latin American statesmen, scholars, and artists; and discussions with noted Latin Americans from throughout the world concerning the latest developments in every sphere of Latin American life.

GERMAN Electoral Data Project

As of Spring, 1975, social scientists will have access to an unprecedented storehouse of machine-readable data on the structure and change of the West-german electorate. Major election studies conducted between 1953 and 1972 will be made available as a result of a project pursued jointly by the Inter-University Consortium for Political Research (ICPR), Ann Arbor; the Zentralarchiv für empirische Sozialforschung (ZA), University of Cologne; and the Zentrum für Umfragen Methoden und Analysen (ZUMA), Mannheim. Nine sets of data, collected by leading German political sociologists, will be made available for secondary analysis by social scientists throughout the world.

The studies contain substantial continuity of focus, allowing for examination of attitudinal and political behavioral change during a major portion of the history of the Federal Republic. Substantively, the studies share much of the focus of electoral studies in other countries, emphasizing in particular the social structural bases of West German politics. There is sufficient breadth of content to allow for a wide range of comparative applications to other national contexts.

The German Electoral Data Project, as the joint development endeavor has been titled, was conceived out of the realization that extraordinarily valuable data resources were extant in

Germany, in particular within the holdings of the Zentralarchiv. The data processing facilities and experience of the two archives were combined with the experience of scholars who had participated in the design and execution of the actual surveys in order to examine, clean, and thoroughly document the various data sets. To facilitate general secondary analysis, the data sets will be accompanied by an English language codebook including a German language questionnaire and/or a Z.A.R. German language codebook. Furthermore, the documentation will also include a brief glossary of potentially troublesome terms which are relatively unique to the German situation. Finally, the entire set will be indexed in a Continuity Guide, which will indicate the extent of cross-study (i.e., through time) continuity of substantive content. Translation and documentation expenses were offset, in part, by support from the Conference Group on German Politics (CGGP).

AMERICAN ACADEMY
of Arts and Sciences Fellows

The American Academy of Arts and Sciences, the second oldest learned society in the United

States, has elected 129 scholars as Fellows, including four political scientists. It also elected 29 foreign Honorary Fellows, including one political scientist.

Founded in 1780 by John Adams and other intellectual leaders prominent in laying the philosophical foundations of the new American nation, the Academy today is a national honorary society with an active center on the West Coast and a developing Midwest organization in addition to its offices in Boston. Its membership of 2,300 includes representatives from the mathematical, physical and biological sciences, as well as law, administration, public affairs, theology, fine arts, and the humanities. It carries on an active program of study and publication on major national and international problems which require the expertise of several disciplines, and it recognizes outstanding contributions through a series of prizes which, along with the Emerson-Thoreau award, include a Social Science Prize, the Rumford Medal (America's oldest scientific prize), and the Amory Prize for Medicine.

The four American political scientists elected are: Bernard Brodie, University of California, Los Angeles; William H. Riker, University of Rochester; Robert C. Tucker, Princeton University; and Robert E. Ward, Stanford University. The foreign political scientist elected is Giovanni Sartori of the University of Florence.

POLICY Studies Organization

The Policy Studies Organization has been active in expanding its publication activities during 1975. The spring symposium of its *Policy Studies Journal* dealt with "Current Problems of Policy Theory" under the editorship of Phillip Gregg. The summer symposium dealt with "Urban Policy" under the editorship of Robert Lineberry and Louis Masotti. The autumn symposium will be on "Economic Regulatory Policy" by James Anderson, and the winter symposium will be on "Civil Liberties and Free Speech Policy" by Stephen Wasby.

Those symposia, as well as previous and subsequent ones, are also being published in expanded form as books in the Policy Studies Organization Series of Lexington-Heath Publishers. In addition to the quarterly symposia, the Policy Studies Organization is now publishing an annual series, with Sage Publications of "Yearbooks in Politics and Public Policy." The first volume on the theme of *What Government Does* was recently published under the editorship of Matthew Holden. The second volume on the theme of *Public Policy Evaluation* will be published later this year under the editorship of Kenneth Dolbeare.

Other recent PSO activities include the forthcoming publication of a *Political Science Util-*

ization Directory based on an agency-by-agency survey of APSA members holding government positions, asking them how political science research and personnel have been and can be used in governmental decision-making. Questionnaires will also be sent this autumn to department chairmen in order to create a second edition of the *Policy Studies Directory* which provides a department-by-department survey of policy studies teaching, research, and related activities. The Policy Studies Organization is currently headed by Duncan MacRae, with Tom Dye as vice president and president-elect, and Stuart Nagel as secretary-treasurer. 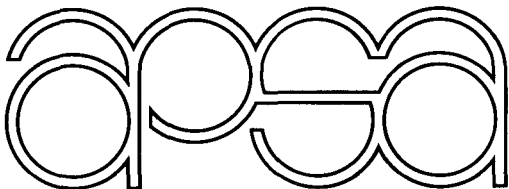
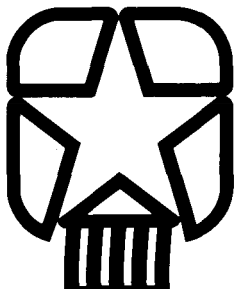
HEALTH Politics and Policy Journal

The new quarterly, *The Journal of Health Politics, Policy and Law*, is being published by the Department of Health Administration of Duke University and co-sponsored by the Committee on Health Politics. It will be an international and interdisciplinary forum for the views of scholars and activists. The principal audience is expected to be composed of those persons who have formed sub-groups on health affairs within academic disciplines, as well as persons directly engaged in health care, such as members of the American Political Science Association and the American Public Health Association and other professional groups.

Each number of the Journal will contain four or five articles of around 20 pages, a Book Review, News and Notes section, a column covering topical events such as the stages of major pieces of legislation, and an updated Bibliography according to broad areas of health research. This format was chosen, in part, to continue and expand the task performed by the former *Health Politics Bulletin*.
