## CONTRIBUTORS

Frances Bostock is currently a researcher on the BP History Project. She received her M.A. from the University of Edinburgh, and was employed as Research Officer from 1972 until 1994 at the London School of Economics and the University of Reading in a series of business history projects. She is the co-author (with Geoffrey Jones) of Planning and Power in Iran (1989) and has written a number of articles on the history of British overseas banking, including "State Bank or Agent of Empire? The Imperial Bank of Persia's Loan Policy, 1920–23," Iran 27 (1989) and "A Bank of Dual Nationality. The Origins and Strategy of the Ionian Bank before 1914," Zeitschrift für Bankgeschichte, 1 (1993). Her most recent article (with Geoffrey Jones) is "Foreign Multinationals in British Manufacturing, 1850–1962," Business History 36 (1994).

Wellington K. K. Chan is professor of history and acting chair of the Department of History at Occidental College. He received a B.A. degree from Yale University, a B.Litt. degree from Oxford University and M.A. and Ph.D. degrees from Harvard University. He has published extensively on the business and socio-economic history of modern China, including an earlier article in Business History Review, "The Organizational Structure of the Traditional Chinese Firm and its Modern Reform" (1982), and more recent ones, "Chinese Business Networking and the Pacific Rim: The Family Firm's Roles Past and Present" (1992), and "The Origins and Early Years of the Wing On Company Group in Australia, Fiji, Hong Kong and Shanghai: Organization and Strategy of a New Enterprise" (1995). His book, Merchants, Mandarins and Modern Enterprise in Late Ch'ing China (1977) has been translated into Chinese and is being published by the Institute of Modern History, the Chinese Academy of Social Sciences, Beijing.

Francesca Fauri is a researcher in the Department of Scienze Economiche of the Bologna University. She gained her Ph.D. in 1994 from the European University Institute in Florence in History and Civilization. The focus of the thesis was Italy's commercial strategy and industrial expansion in the 1950s. She is the author of a book on local industrial development in Romagna (Lo sviluppo industriale

a Forli e Cesera) and is now working on a comparative study on the development of business studies in Italy and Great Britain since 1850.

Geoffrey Jones is professor of Business History in the Economics Department of the University of Reading, U.K. He received his M.A. and Ph.D. from Cambridge University, and taught economic history at the London School of Economics from 1979 to 1988 before moving to Reading. He is the author of many articles and of several books, including The State and the Emergence of the British Oil Industry (1981), Banking and Empire in Iran (1986), Banking and Oil (1987), British Multinational Banking 1830–1990 (1993) and The Evolution of International Business (1996). At present he is working on a study of the competitive strategies and organizational capabilities of international trading companies from the nineteenth century until the present day.
