In the 1970s and 1980s the countries of Latin America dealt with their similar debt problems in very different ways—ranging from militantly market-oriented approaches to massive state intervention in their economies—while their political systems headed toward either democracy or authoritarianism. Applying the tools of modern political economy to a developing-country context, Jeffrey Frieden analyzes the different patterns of national economic and political behavior that arose in Argentina, Brazil, Chile, Mexico, and Venezuela. He argues that variations in official borrowing policies and responses to lending cut-offs imposed by foreign creditors are best explained not by international but by domestic factors, particularly lobbying by powerful interest groups.

SUMMER WORKSHOP IN INTERNATIONAL ORGANIZATION STUDIES

PURPOSES

The American Society of International Law and the Academic Council on the United Nations System are jointly sponsoring the second summer workshop in international organization studies at Dartmouth College from July 12 to 24, 1992. The purposes of the workshop are:

1. to enhance professional development in international organization studies;
2. to stimulate new teaching methods in IO studies and encourage new directions in research;
3. to strengthen contacts between scholars in international relations and international law;
4. to develop contacts between international officials and academic faculty.

WORKSHOP PROGRAM

The workshop will be under the direction of Professor Michael Schechter of Michigan State University and Professor Edwin Smith of the Law School at the University of Southern California. Guest lecturers at the first workshop in 1991 included Professor Thomas Franck of the School of Law of New York University and Editor of the *American Journal of International Law*, Ronald Spiers, Under Secretary General of the United Nations and Dr. Oran R. Young, Director of the Institute of Arctic Studies at Dartmouth. The program of the workshop will be made up of several components:

1. Seminar discussions on teaching IO in law schools and graduate and liberal arts programs;
2. Reports on current IO research, including the significant literature and case materials;
3. Review of documentary and archival resources for research;
4. Meetings with senior scholars in the field and with international officials;
5. Panels of scholars and practitioners on current issues in international organization.

PARTICIPANTS

Participants will be selected by a joint ASIL/ACUNS committee. Participation is open to faculty members from law schools and social science departments in colleges and universities in Canada, Mexico and the United States. The committee will be interested in receiving applications from faculty members in their early years of teaching and, in addition to specialists in international law and international relations, from historians, economists and specialists in fields like development studies and environmental protection who are concerned with the legal and political requirements of international cooperation. Participants will receive:

1. A stipend of \$1,000 to cover an honorarium and travel expenses (increased to \$1,250 for those travelling a distance greater than 1500 miles); and
2. Daily living expenses for the 12 days of the workshop with accommodations being provided in college dormitory suites.

Applications are due by February 1, 1992 with selections to be made by March 1. There is no standard application form. Applicants should submit a full curriculum vitae and a statement of their current teaching and research interests and arrange to have two letters of recommendation sent directly to:

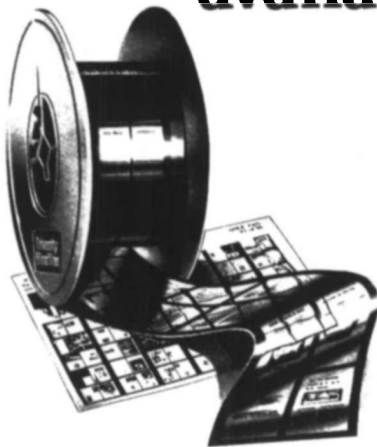
