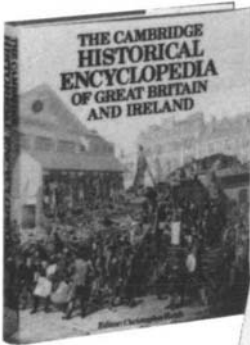

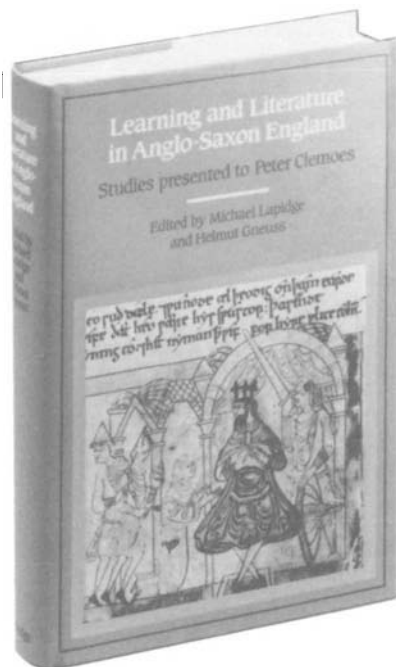

Fourteen leading specialists in the field of Anglo-Saxon studies have contributed to this substantial collection of essays in honour of Peter Clemoes, founder of *Anglo-Saxon England* and recently retired as Elrington and Bosworth Professor of Anglo-Saxon in the University of Cambridge. The book is divided into two complementary parts. The first looks at the background to Anglo-Saxon learning, in particular at the composition of monastic and private libraries and the nature of the individual works available in them. The second examines the contents and sources of individual texts and reviews the problems of interpretation and transmission these pose for scholars.

panel from Jerome's life of the desert ascetic, Paul the Hermit, reinforces the Cross's representation of the spirit of early Northumbrian monasticism. The analysis of the homiletic sources used for the ninth-century Old English Martyrology further testifies to the author's scholarly standards and extensive library resources, while the other source analysis reveals Insular expansion of the traditional lists of scriptural and other events said to have occurred on a Sunday and English linkage of such lists with the letter urging enforcement of Sunday believed to have been sent from heaven by Christ himself. The study of Aldhelm's conception of meaning shows that in deriving etymologies from Isidore for his riddles he often went beyond his source in exploring how a name may determine the nature of the thing named. The enhancement of our understanding of early kingship comes from an examination of the evidence relating to the kingdom of the East Saxons. Textual criticism produces the interesting certainty that Exeter Riddle 40 was translated from the text of Aldhelm's 'Creatura' *enigma* in an extant continental manuscript which came to England early in the tenth century. Phonology demonstrates that there is no formal objection to identifying the 'Eowe' of *Widsith* 26a with the 'Aviones' of Tacitus.

The systematic bibliography of work in all branches of Anglo-Saxon studies covers 1984.

A rich diversity of evidence and of topic characterizes this volume. A pioneer account of a unique group of Anglo-Saxon embroideries preserved on the continent and the publication of a previously unknown charter are two outstanding 'firsts'. Themes illuminated are as varied as the status of women, early urban history, the nature of medical collections, the standing of Marian feasts and the function of musical notation. The study of Old English poetry is advanced textually, codicologically, culturally, linguistically and critically. Innovation and established practice go hand-in-hand: a record of the first conference of the International Society of Anglo-Saxonists and versions of six papers read at that conference are included, and so too is the usual full bibliography of the preceding year's publications; two pages of colour plates (showing parts of the embroideries) accompany twelve pages of black-and-white ones.
