His main research interests include state building, state capacity, bureaucracy and governance, democratization and democratic development, conflict studies, and comparative historical analysis. His recent publications include “The Multiple Influences of the State on Democratic Breakdowns” in the *APSA Comparative Democratization Newsletter* and “Economic Crisis, Bureaucratic Quality, and Democratic Breakdown” in *Government and Opposition*.

John J. Clegg is a PhD candidate in sociology at New York University. His research covers the roots of mass incarceration, the economics of slavery, and the impact of African American political and military mobilization during the Civil War and Reconstruction.

Katie E. Corcoran is an assistant professor of sociology at West Virginia University. Her areas of expertise are in religion, organizations, criminology, social movements, and social networks. Corcoran has published articles in the *British Journal of Social Psychology*, *Sociological Forum*, the *Journal for the Scientific of Religion*, *Sociology of Religion*, *Social Science History*, *Sociological Inquiry*, and *Rationality and Society*. She recently published the book *Religious Hostility: A Global Assessment of Hatred and Terror* with Rodney Stark.

Elise M. Dermineur is an associate professor of history at Umeå University and a Pro Futura Scientia Fellow at the Swedish Collegium for Advanced Study in Uppsala. She has published articles in the *Journal of Social History*, *The Journal of Interdisciplinary History*, *Traverse Revue d'Histoire – Zeitschrift für Geschichte*, and *Social Science History*. In 2017, she published *Gender and Politics in Eighteenth-Century Sweden*, a political biography of the Swedish Queen Lovisa Ulrika (1720–82). She is editing a collection of essays on women and credit activities in preindustrial Europe (Brepols, 2018).

Gregory J. Goalwin holds a PhD in sociology from the University of California, Santa Barbara and is currently Lecturer in Sociology at California State University, Channel Islands. His research examines religion, culture, and the formation of ethnic and national identity, with particular focus on Ireland and the early years of the Republic of Turkey.

Jørgen Møller has a PhD from the European University Institute in Florence, Italy (2007) and is currently a professor at the Department of Political Science, Aarhus University, Denmark. His research interests include conceptualization of democracy, postcommunist political change, patterns of democratization and democratic stability, patterns of state formation, the origins of representative institutions, and comparative methodology.

Martin Petzke is a lecturer at the Department of Sociology, University of Lucerne, Switzerland. His research focuses on the sociology of quantification, the evangelical movement, immigration, and the globalization of social fields. He most recently authored the article “Taken in by the Numbers Game: The Globalization of a Religious ‘Illusio’ and ‘Doxa’ in Nineteenth-Century Evangelical Missions to India,” *Sociological Review Monographs* 64: 124–45 (2016).

Steven Pfaff is professor of sociology at the University of Washington. His recent work has appeared in the *American Sociological Review*, *Explorations in Economic History*, *Theory and Society*, and the *Journal for the Scientific Study of Religion*. His fields of research include comparative and historical sociology, collective action and social movements, and religion and political sociology.

Bernd Wurpts is a PhD candidate in sociology at the University of Washington. Bernd’s fields of interest are economic sociology and social network analysis. His work focuses on the analysis of social relations and its effects in various social contexts. In his MA thesis, he investigated the role of individual social networks in finding dentists as published by the Institute of German Dentists. In the forthcoming edited volume on “Prospects of Historical Network Research,” Bernd discusses network research in economic history with a short analysis of medieval Hansa trade.

Dr. Henry Yeomans is lecturer in criminology and criminal justice at the University of Leeds. He researches alcohol, behavioral regulation, and historical criminology. His recent publications include the monograph *Alcohol and Moral Regulation* published by Policy Press in 2014 and articles in *Sociology*, *The Sociological Review*, and *Law, Crime and History*. He was awarded the Socio-Legal Studies Association’s Socio-Legal Theory and History Prize in 2015 as well as the Sage Prize for Innovation and Excellence in 2012.
