SECOND CONFERENCE OF THE CARIBBEAN SCHOLARS

Date: April 15–19, 1964 *Location:* Mona, Jamaica

Content: Papers were presented on POPULATION AND LABOR MOVEMENTS; PRESENT AND FUTURE CONSUMPTION PATTERNS; ECONOMIC DEVELOPMENT; INCOME DISTRIBUTION; POLITICAL AND SOCIAL CHANGE; DEVELOPMENT OF THE CARIBBEAN ELITE.

Publication of Proceedings: To appear in book form by the Summer, 1965 as a publication of the Institute of Caribbean Studies.

FIRST MEETING OF THE FOREIGN AREA RESEARCH COORDINATION GROUP: LATIN AMERICAN SUBCOMMITTEE

Date: July 1, 1964 *Location:* Washington, D.C.

Member agencies: Agency for International Development, United States Information Agency, Department of State, Central Intelligence Agency, Special Operations Research Office, Department of HEW.

Content: Discussions focused on the recommendation to prepare tentative lists identifying long and short term government research needs related to Latin America. A resolution to effect this recommendation was passed.

Date: August 20, 1964 *Location*: Washington, D.C.

Content: Discussion was on compiling a list of available specialists on Latin America. It was suggested that bi-monthly reports be issued by the member agencies citing research projects which have been planned, are in progress, or have been completed. (See meeting of July 1 above.)

Date: August 27–Sept. 8, 1964 *Location*: Burg Wartenstein, Austria

Participants: Co-organizer: Oscar Lewis (University of Illinois); Chairmen: Edward M. Bruner (University of Illinois) and Aidan Southall (Syracuse University).

Content: Papers were presented on SELECTIVITY IN RURAL-URBAN MIGRATION: THE CASE OF HUAYLAS, PERU (Stillman Bradfield, Pennsylvania State University); THE FUNCTIONS OF REGIONAL ASSOCIATIONS IN URBANIZATION: WEST AFRICA AND PERU (Kenneth Little, University of Edinburgh); LOCALITY

POWER IN RELATION TO SUPRA-LOCAL POWER INSTITUTIONS (Anthony Leeds, University of Texas); SOCIOLOGICAL, CULTURAL AND POLITICAL CHARACTERISTICS OF SOME RURAL INDIANS AND URBAN MIGRANTS IN PERU (William Mangin, Syracuse University).

XXXVI CONGRESO INTERNACIONAL DE AMERICANISTAS

Date: August 31-Sept. 9, 1964 *Location:* Barcelona, Madrid, Sevilla, Spain

Participants: 624 members from 38 countries.

Content: There were some 457 papers presented to the Congreso of which about 80% had a Latin American content. Proceedings will be published under the editorship of J. Alcina, general Secretary of the Congreso.

THIRD MEETING OF FOREIGN AREA RESEARCH COORDINATION GROUP: LATIN AMERICAN SUBCOMMITTEE

Date: September 15, 1964 *Location:* Washington, D.C.

Content: Further discussion was held on the ideas presented at the first and second meetings. It was decided that all Subcommittee members should prepare a draft of directory information on offices in their agencies responsible for research on Latin America. (See meeting of July 1 above.)

EUROPEAN-LATIN AMERICAN CONFERENCE

Date: October 4-9, 1964 *Location:* Villa Serbelloni Bellagio (Como), Italy

Participants: Included members of the academic community and the Foundations, represented by 6 Latin Americans, 12 Europeans and 7 North Americans.

Content: The topics for discussion were EUROPE'S RELATIONS WITH LATIN AMERICA—TODAY'S CHALLENGES; THE U.S. EXPERIENCE IN LATIN AMERICAN AFFAIRS; SOCIAL AND ECONOMIC AFFAIRS; EDUCATION AND TRAINING; INFORMATION EXCHANGE, ROSTERS, INVENTORIES; LIBRARIES AND DOCUMENTATION.

Several proposals for expanding strengthening international collaboration between Europe and Latin America were brought forth:

- a) In Europe, where Latin American studies are actively pursued, institutions concerned with Latin American affairs should be established.
- b) A clearing-house for the informal European network is to be established at the Center of Latin American Research and Documentation of the University of Amsterdam. A primary function of the Amsterdam clearing-house will be to publish a semi-annual bulletin on a subscription basis and

more frequent short reports as needed. (This proposed bulletin was produced on April 1, 1965).

- c) A meeting of European scholars and librarians (including 2 or 3 specialists from the U.S.A.) should be held to discuss Latin American library holdings in Europe, acquisition policies, and similar problems.
- d) A roster of Latin Americanists in Europe should be compiled and published.
- e) The subsidized program for Latin American translations administered by the Association of American University Presses should be expanded to include European publication and translation of works into the principal European languages.
- f) A multi-national fund or system of support should be established for extending financial assistance to Latin American scholars and senior graduate students abroad whose support from their home countries has been discontinued for non-academic reasons.

It was further recommended that to continue the research on Latin America, the areas of research funds, assignments, vacation periods for scholars, and previous experience of others must be more fully investigated and taken advantage of. It was also recommended that students be encouraged by increased scholarships, fellowships, etc., and that better facilities for incorporating Latin American students into community and university life be made more abundant.

TRENDS IN SOCIAL SCIENCE RESEARCH IN LATIN AMERICAN STUDIES
CONFERENCE

Date: October 9–11, 1964 *Location:* Palo Alto, California

Participants: There were 34 participants in the discussions representing all the social sciences from 14 major universities in the U.S.; the University of Buenos Aires; the University of Mexico; Facultad Latinoamericana de Ciencias Sociales, University of Chile and Oxford University.

Content: Papers were presented on RECENT THEORIES OF DEVELOPMENT (by Ivan Vallier, Columbia University, presently on leave at the University of California, Berkeley); TRAINING FOR COMPARATIVE AND INTERDISCIPLINARY STUDIES (by Jane Fearer, Oxford University); A LATIN AMERICAN PHENOMENON—THE MIDDLE CLASS MILITARY COUP (by José Nun, University of Buenos Aires, on leave at the University of California, Berkeley).

Sponsorship: Institute of International Studies, University of California, Berkeley.

MEETING OF THE SOCIETY FOR LATIN AMERICAN STUDIES

Date: October 17, 1964 *Location:* Cambridge, England

Content: A lecture was given by J. E. S. Thompson on THE ANCIENT MAYA OF CENTRAL AMERICA. The meeting in Fitzwilliam House was attended by about 60 members who had the opportunity to discuss problems of common interest such as: the possible functions of the Society, the exchange of information on ways and means of reducing the costs of visits to Latin America.

FIFTEENTH NATIONAL SOCIOLOGICAL CONGRESS

Date: October 19–23, 1964 *Location:* Tepic, Nayarit, Mexico

Content: The Congress was devoted to the sociology of agrarian reform. A special invitation was extended to North American rural sociologists.

FIFTH QUADRENNIAL CONGRESS OF THE INTER-AMERICAN INDIAN INSTITUTE

Date: October 19–25, 1964 *Location:* Quito, Ecuador

Content: Eighteen countries of the hemisphere sent official representatives to the Congress. The principal topics considered were socio-economic development, the use of native languages in education, the training of personnel for community development work, the peculiar problems of the jungle populations, native arts and crafts, problems of health and sanitation, and the role of the Indian woman in socio-economic development.

Elected president of the Congress was Gonzalo Rubio Orbe, Director of the Ecuadorian Indian Institute. Rubio also served as chairman of the organizing committee for the host government. The opening address of the Congress on behalf of the delegates was delivered by Gonzalo Aguirre Beltran of Mexico, Deputy Director of the Mexican Indian Institute. James E. Officer of the United States, Associate Commissioner of Indian Affairs, offered closing remarks for the visiting delegations.

The 55 resolutions approved by the Congress included one relating to the future activities of the Institute. It recommended, among other things, the establishment of a permanent department of social sciences. Such a department is now in the process of being set up, and Alfonso Villa-Rojas of Mexico has been named its head. Other important resolutions enacted by the Congress concern such matters as agrarian reform, relocation of indigenous populations, promotion of Indian arts and crafts and the establishment of national training centers for community development workers.

The US delegation to the Quito Congress was one of the largest and included representatives of the Bureau of Indian Affairs and the Agency for International Development. Heading the delegation was William W. Keeler, Principal Chief of the Cherokee Indian Tribe and Chairman of the Executive Committee of the Phillips Petroleum Company. The permanent US representative to the

Institute, Dr. William H. Kelly of the University of Arizona, was a member of the delegation, as were three leaders of American Indian tribes: Robert Jim (Yakima) of Toppenish, Washington; Irwin Santiago (Pueblo) of Laguna, New Mexico; and Agnes Savilla (Mohave) of Parker, Arizona.

The Inter-American Indian Institute, established at Patzcuaro, Mexico, in 1940, will hold its Sixth Congress in Mexico City in 1968. The delegates at Quito also voted to hold an interim meeting of official national representatives in Lima in 1966. Permanent headquarters for the Institute are in Mexico City, and the Executive Secretary is Miguel Leon-Portilla of Mexico.

Again in 1965 the Department of Social Affairs of the Organization of American States, in conjunction with the Inter-American Indian Institute, is sponsoring training centers for specialists in Indian community development from various countries of the hemisphere. Among those taking part in these seminars were Edward H. Spicer, University of Arizona; James E. Officer, Associate Commissioner of Indian Affairs; Aurelio Rueda Camacho, Colombian Ministry of Government; Gonzalo Aguirre Beltran, Deputy Director of the National Indian Institute of Mexico; E. Ander Egg, Gabriel Ospina Restrepo, Sam Shulman, and Cesar Cisneros, Organization of American States; Anibal Buitron and Olen Leonard, United Nations.

COLLOQUY ON THE RELATIONSHIPS BETWEEN PSYCHOLOGY AND SOCIOLOGY

Date: November 9–11, 1964 *Location:* Buenos Aires, Argentina.

Content: The theme of the conference was "Psychology and Sociology: Theoretical Problems and Empiric Relationship." Eleven papers were presented. Participating in the debates were sociologists, psychiatrists, and social psychologists.

Sponsorship: Institute of Economic and Social Development (INDS).

INTERNATIONAL SEMINAR ON PLANNING AND ADMINISTRATION OF AGRARIAN REFORM ON THE NATIONAL, REGIONAL, AND SPECIFIC PROJECT LEVEL

Date: November 9–18, 1964 *Location:* Maracay, Venezuela

Content: The seminar was directed by Claudio Escoto, Associate lawyer of the IICA-CIRA. Sixty-two professional public employees who work on the Agrarian Reform of Venezuela, Colombia, Peru, Bolivia, and Chile, assisted as interpreters, commentators and participants.

Various recommendations were approved on the necessity of organizing or reinforcing the communication systems of the National Agrarian Reform Institutes and the necessity for the preparation of a glossary of terms and words relating to agrarian reform. (Proceedings published in 1965.)

FOURTH MEETING OF FOREIGN AREA RESEARCH COORDINATION GROUP: LATIN AMERICAN SUBCOMMITTEE

Date: November 12, 1964 *Location:* Washington, D.C.

Content: Reports on the progress of gathering data for the directory proposed in the Third Meeting in September. (See meeting of July 1 above.)

LATIN AMERICAN CONSULTANTS WORKSHOP. A conference on the Interamerican Center for Land and Water Resource Development

Date: November 16–20, 1964 *Location:* Logan, Utah

Content: The meeting was organized and directed by members of the Utah State faculty and staff who have been undertaking preliminary phases in the execution of the OAS contract to establish an Interamerican Land and Water Resource Center to be located in Mérida, Venezuela. Latin American delegates, for the most part on the director-level of government ministries, participated in the discussions. Among other objectives the workshop recommended: "the Center will help the member nations of OAS to: Create or improve the institutions that are working in the use of water and land resources; and make investigations and studies on the conservation and utilization of these resources. The Center will promote the interchange of technical information and experience among the professionals and the institutions related to the field of the member countries of the OAS."

ANNUAL MEETING OF THE AMERICAN ANTHROPOLOGICAL ASSOCIATION

Date: November 21, 1964 *Location:* Detroit, Michigan

Content: The Latin American symposiums were: THE PRESENTATION OF SELF IN HISPANIC SOCIETY, papers were by Arthur Rubel, Anthony Luria, Octavio Romano, Eric Wolf, Michael Kenny; EXPLORATIONS IN ETHNOGRAPHIC METHODS: MAYA SPEAKING INDIANS IN THE STATE OF CHIAPAS, MEXICO, discussion headed by Duane Metzger; papers given by Duane Metzger, June Nash, and Gerald Williams.

THIRD NATIONAL SYMPOSIUM OF ARCHEOLOGY

Date: November 27–December 1, 1964 *Location:* Chiclayo, Peru

Latin American Research Review

Content: Emphasis was placed on current state of archaeological investigation in Peru, and the need for legislation to both stimulate research and protect archaeological monuments. This Symposium terminates the program of academic meetings organized by the Patronato Nacional de Arqueología for 1964. Parts of this program were the symposia of the Ica, Trujillo, and Round Table Meetings in Paachacamac.

CONFERENCE ON LATIN AMERICAN STUDIES

Date: December 2–3, 1964 *Location:* Cuernavaca, Mexico

Content: Thirty-six participants represented twenty major universities, in addition to the Ford Foundation, Foreign Area Fellowship Program, and the Social Science Research Council. Discussion topics were: REVIEW OF CURRENT MAJOR ACTIVITIES IN THE FIELD OF LATIN AMERICAN STUDIES; FELLOWSHIPS RELATING TO LATIN AMERICAN STUDIES; POST-DOCTORAL FELLOWSHIPS IN LATIN AMERICAN STUDIES; EXCHANGES INVOLVING LATIN AMERICAN AND AMERICAN SCHOLARS; RESEARCH CENTERS AND FIELD STATIONS LOCATED IN LATIN AMERICA; THE EXCHANGE OF INFORMATION PERTAINING TO LATIN AMERICAN STUDIES; ORGANIZATION AND OPERATIONS OF THE AFRICAN STUDIES ASSOCIATION; FORMATION OF A LATIN AMERICAN STUDIES ASSOCIATION. As a result of the discussion on information exchange, universities were canvassed for potential support, and the *Latin American Research Review* is being published.

FIFTEENTH ANNUAL CONFERENCE ON THE CARIBBEAN

Date: December 2–5, 1964 *Location:* Gainesville, Florida

Content: The general topic was THE CARIBBEAN: ITS HEALTH PROBLEMS. Public lecture was sponsored by the Department of Agriculture on HOUSING IN THE CARIBBEAN. The subjects of the 5 Round Tables were PHYSICAL AND CULTURAL ENVIRONMENT; FOOD AND NUTRITION; SANITATION; DISEASES; HEALTH ADMINISTRATION. Twenty-one participants entered into the discussions of the Round Tables.

Sponsorship: Center for Latin American Studies and the J. Hillis Miller Health Center, University of Florida.

FOURTH MEETING OF THE PAN-AMERICAN HEALTH ORGANIZATION—Conference on Malnutrition and Mental Development

Date: December 14, 1964 *Location:* Bethesda, Maryland

Participants: There were 24 participants including representatives of Latin American research groups and U.S. hospitals and universities.

Content: The focus of the meeting was on the relationship between the widespread malnutrition of Latin American children and their mental development.

The purposes of the conference were: to develop possible topics for future meetings in Latin America; to determine whether support of such meetings constitutes the most effective contribution PAHO can make to research which needs to be undertaken; cross-cultural studies involving such groups as the National Institute of Child Health and Human Development and the Association for the Aid of Crippled Children; to bring together investigators and specialists of different disciplines who have a common interest in a particular problem.

NINTH INTER-AMERICAN CONGRESS OF PSYCHOLOGY

Date: December 17–22, 1964 *Location:* Miami, Florida

Participants: One hundred and sixty-one scholars participated in the Congress representing the Latin American countries of Argentina, Brazil, Costa Rica, and Mexico; and 10 major universities in the United States.

Content: The theme was: PSYCHOLOGY FOR CULTURAL PROGRESS. The titles of the nine Symposia were: IDENTIFYING, MEASURING, AND REWARDING GIFTEDNESS IN THE ARTS; COMMUNITY MENTAL HEALTH—INDIVIDUAL ADJUSTMENT OR SOCIAL PLANNING; CROSS-NATIONAL RESEARCH ON CHILDREN'S DEVELOPMENT IN COMPETENCE; CHANGING PATTERNS IN CHILD AND FAMILY LIFE; CROSS-CULTURE STUDIES IN INFORMATION DIFFUSION; COLLABORATIVE RESEARCH IN YUCATAN; EXCHANGE OF STUDENTS AND TEACHERS AMONG THE AMERICAS; TRANS-CULTURAL STUDIES OF THE DEVELOPMENT OF THE PERSONALITY OF THE SCHOLAR; PSYCHOLOGICAL PROBLEMS IN HOUSING.
