THE POLITICAL FOUNDATIONS OF INTERNATIONAL LAW

By Morton A. Kaplan, *University of Chicago*, and Nicholas deB. Katzenbach, *University of Chicago Law School*. The joint effort of a political scientist and a lawyer, this book employs a systems theory of international politics to demonstrate forcefully the extent to which international politics is constrained by legal rules, how these rules in turn respond to political considerations, and how much of the struggle of international politics is a struggle to determine the values governing international political behavior. This unusual book clarifies problems such as development of space law, admission of Red China to the United Nations, growth of the new supranational organs such as NATO, the communist bloc, the European Economic Community, and the United Nations itself. Also, it examines development of new areas of international law as a consequence of new institutions of political organization as well as the growing role of the individual and of private organizations as participants in the international legal and political process. 1961. 372 pages. \$6.95.
