Eleanor Giraud is course director of the MA in Ritual Chant and Song at the Irish World Academy of Music and Dance, University of Limerick, Ireland. Her current research examines the chant and liturgy of the Dominican Order in the Middle Ages. She completed her Ph.D. at the University of Cambridge (2014) on 'The Production and Notation of Dominican Manuscripts in Thirteenth-Century Paris'.

Justin Lavacek is Assistant Professor of Music Theory at the University of North Texas, where he specialises in the theory and analysis of European music before 1750. He holds a Ph.D. in music theory from the Jacobs School of Music, Indiana University.
