Foreword

We wish to emphasise the fact that Biographical Studies is, as its subtitle indicates, an experimental work. In the foreword to the first number we wrote:

"The object of the present publication is to provide the means by which the researches of many individual scholars can gradually be assembled and presented for general use. In addition to separate biographies, it will contain articles covering several generations of family history; and it will also contain briefer studies and notes about men and women for whose lives the collections are still incomplete. These briefer studies and notes will serve the purpose of recording evidence as it comes to light and of stimulating further research, so that they can eventually be incorporated in fuller biographies at a later stage in the work. The intention, therefore, is not to work consecutively through the alphabet from A to Z, nor to cover the period in chronological sequence, but to publish material from anywhere in the field of research as soon as it becomes available."

Corrections to articles will always be gratefully received. The next number (July 1952) will complete the first volume, and it will contain, in addition to a full index of persons mentioned throughout the volume, a list of corrections and additions to some of the articles so far published.

Attention is called to the corrigenda list at the end of each number.

Biographical Studies is reproduced from typewriting on lithographic plates which are checked against copy by the

printer's reader as they come off the machine. These plates cannot be examined by the editor until after they have been chemically "set", and corrections made by the editor entail, in each case, the retyping and setting of the whole plate. Minor errors missed by the printer's reader, or due to faulty copy, therefore, are not corrected in the text but are indicated in the corrigenda list at the end of the number.
