THE CONTRIBUTORS

STEPHEN B. Jones is Professor of Geography at Yale University. His most recent publication is a textbook, *Geography and World Affairs* (1953), and he is currently engaged in a study of the geographical factor in national power under a grant from the Geography Branch of the Office of Naval Research.

HENRY W. EHRMANN is Professor of Political Science at the University of Colorado. Author of French Labor from Popular Front to Liberation (1947), he is working on a study of the policies, ideologies, and structure of the French employers' organizations.

P. J. VERDOORN is Chief of the Structural Relations Division of the Central Planning Bureau of the Netherlands Government and Professor of Market Research and Business Statistics at the Rotterdam School of Economics. Among his publications is "The Netherlands and the Economic Consequences of an Economic Integration of Western Europe" (1952).

MORTON A. KAPLAN is engaged in research in Washington for the Brookings Institution study of American foreign policy from 1945 to 1955, and is writing a book on the theory of statecraft. He has contributed previously to World Politics.

CHARLES P. KINDLEBERGER is Professor of Economics at Massachusetts Institute of Technology, and has served with the Department of State. He is the author of *International Economics* (1953).

HERBERT MARCUSE is Professor of Political Science at Brandeis University and a Research Fellow at the Russian Institute, Columbia University. The author of Reason and Revolution (1941), he is working on a book dealing with Soviet Marxism and on one entitled Beyond the Reality Principle: A Philosophy of Psychoanalysis.

ROBERT TRIFFIN is Professor of Economics at Yale University, and has served with the International Monetary Fund and the European Payments Union. He is abroad on leave, preparing a book on monetary developments in postwar Europe.

DAVID E. APTER is a post-doctoral Fellow at the Center of International Studies, Princeton University. He has engaged in research in British West Africa under the auspices of the Social Science Research Council.

SIGMUND NEUMANN is Professor of Government and Modern History at Wesleyan University. Co-author of European Political Systems (1953), he is now editing and contributing to Modern Political Parties: The Comparative Approach, which will be published next winter.
