CONTRIBUTORS

Carl T. Fumagalli received his doctorate in anthropology from the State University of New York at Buffalo in 1977. He conducted field work among nomadic pastoralists in Kenya, 1974-76. He is currently working on a Samburu-English dictionary.

Mitchell Harwitz is Associate Professor of Economics at SUNY-Buffalo. He has conducted research in Liberia (1961) and in Kenya (1969-71), where he was Director of the B.Phil. Programme at the University of Nairobi. He is co-editor, with Melville J. Herskovits, of *Economic Transition in Africa* (Evanston, 1964); co-author, with R.W. Clower, G. Dalton, and A.A. Walters, of *Growth Without Development: An Economic Survey of Liberia* (Evanston, 1966); and the author of a number of articles on African economic development.

Graham B. Kerr is Assistant Professor of Sociology at SUNY-Buffalo. He studied tobacco growers in Nigeria (1963-65) and the diffusion of innovations in that country (1965-67), and conducted demographic research in Afghanistan, 1971-75. He is the author of "Selected Bibliography on Communication in Africa" (*Canadian Journal of African Studies* 3:1, 1969) and "Field Experiments on Communication and Modernization," in E.M. Rogers, J. Ashcroft, and N.G. Roling, eds., *Diffusion of Innovations in Brazil, India, and Nigeria* (East Lansing, 1970).

John Van Dusen Lewis is Assistant Professor of African Studies at Howard University. He has worked as Research Associate in Social Anthropology with the International Livestock Center for Africa, in Mali, 1974-75, 1977, and 1978.

Seleshi Sisaye is a doctoral candidate in development sociology at Cornell University. He was part of a Ford Foundation-sponsored team to study urbanization, assimilation, and development in Addis Ababa (1973-74), under the direction of Asmarom Legesse. He is the author of "Industrial Conflict and Labor Politics in Ethiopia: A Study of the March 1974 General Strike" (*Plural Societies* 8:2, 1977).

David H. Spain is Associate Professor of Anthropology and Chairman of African Studies at the University of Washington, Seattle. He conducted field research in Bornu, Nigeria, in 1965, 1966-67, and 1975. He is co-author of *Tradition and Identity in Changing Africa* (New York: Harper & Row, 1973), and co-author of *Survey Research in Africa* (Evanston: Northwestern University Press, 1973), both with William O'Barr and Mark Tessler.

Irving J. Spitzberg, Jr. is Associate Professor, Faculty of Educational Studies and the Center for Policy Studies, SUNY-Buffalo. He conducted research on educational policy in Kenya in 1973. He is the editor of *The Exchange of Expertise: The Counterpart System and the New International Order* (Westview Press, 1978), and the author of various articles on international affairs.

Phillips Stevens, Jr. is Associate Professor of Anthropology and Chairman of African Studies, SUNY-Buffalo. He was Ethnographer for the Nigerian Federal Department of Antiquities, 1963-66, and conducted ethnological research in Nigeria in 1969-71, 1974, and 1976. He was President of the New York African Studies Association, 1977-78. He is the author of several publications that deal with aspects of traditional cultural systems of various peoples of Nigeria.

Victor C. Uchendu is Professor of Anthropology and Director of the African Studies Program, University of Illinois, Urbana-Champaign. His African field work was conducted in Nigeria (1961-62, 1972, and 1977-78), Kenya, Tanzania, Uganda, and Zambia (variously from 1960 to 1967), and Ghana (1967-68). He was President of the African Studies Association (1976). He is the author of *The Igbo of Southeast Nigeria* (New York: Holt, Rinehart, & Winston, 1965), and the co-author of *Agricultural Change in Tropical Africa* (Cornell University Press, 1978), among other publications.
