This collection was the property of Rudolf Mosse (1843–1920), a successful businessman who founded the first major advertising agency in Germany and went on to become publisher of the influential *Berliner Tageblatt* and other daily newspapers.

Filmed from Mosse's personal book collection deposited at the Leo Baeck Institute in New York City, this collection contains 94 business histories and biographies from Mosse's era and earlier.

Included are in-depth portraits of the *Frankfurter Zeitung* for 1856–1906 and seven other newspapers, some going back to the 18th century. The two major German steamship lines are represented; and there are early histories of the Siemens, Krupp, and Zeiss dynasties among others, including the Fuggers of the Renaissance.

A richly illustrated review of the Meissen porcelain industry and a history of early pencil manufacture by the Faber company—these and representative banks, printers and publishers, and chemical and electric power companies are among the subjects included. A few titles reflect Mosse's cultural interests and pride in his Jewish heritage. All are in German.

Virtually all titles cover the late 19th and early 20th centuries. Many trace their subjects' histories back into the 18th century or earlier.

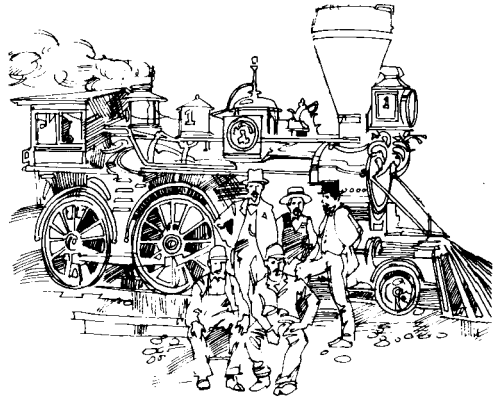

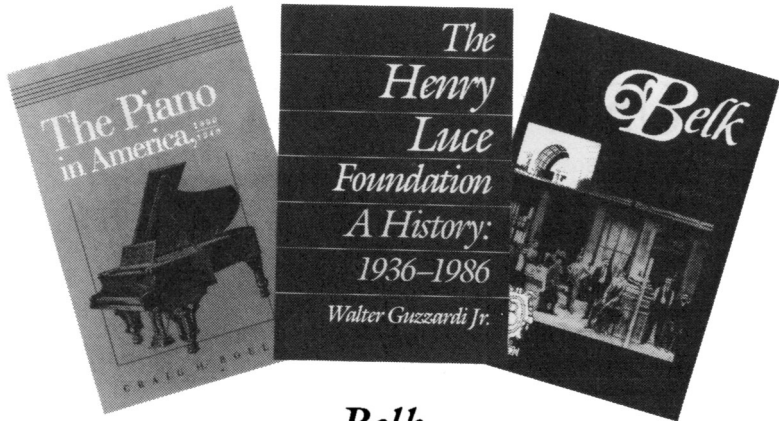

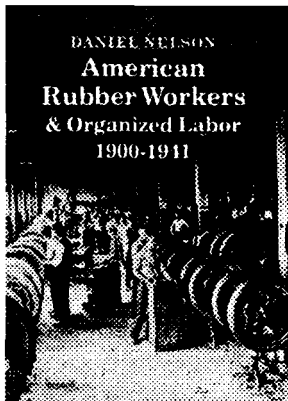

Daniel Nelson tells the story of the changes that occurred in the rubber products industry between the turn of the century and the U.S. entry into World War II. Newcomen Awards in Business History

For the best article published in the *Business History Review* during the previous year the Society will award a prize of \$300 and a scroll. For the best article published in the *Business History Review* during the previous year by a graduate student or a recent Ph.D. who has not published a book in business history, the Society will award a special prize of \$150 and a scroll. Criteria for selection include originality, value, breadth and interest of contribution, quality of research materials and methods, and quality of presentation.

Winners will be selected by a panel of judges consisting of the editors and the members of the editorial board of the *Business History Review*, none of whom shall be eligible to receive a prize. The awards are administered by the editorial office of the *Review*. No special prize will be awarded in years when, in the opinion of the judges, no eligible article suitable for the prize was published, and no person may be awarded both prizes in any one year.

Thomas Newcomen Book Award in Business History

The Newcomen Society of the United States, in cooperation with the *Business History Review*, will award in 1989 the ninth in a series of triennial prizes consisting of \$1,000 and a scroll for the best book on the history of business published in the United States between 1986 and 1988. "Business history" is defined in its broadest sense to include not only the history of firms or industries, but books tracing interactions of business leaders, analyses of business philosophy or behavior, and studies of the adjustment of businesses and businesspeople to their economic, political, and social environments. Criteria for selection will include contribution to knowledge, depth of analysis, soundness of reasoning, clarity of style and organization, and general readability and format.
