The Law of Nations is *living* law — living in the interaction and exchanges between nations. The history of international law corresponds with the political and diplomatic history of the same period. It is therefore of interest not only to legal experts and juridical scholars, but also to historians, political scientists, diplomats, and journalists, whose interest in political history is often sparked by contemporary events.

Despite the relevance of the history of the law of nations, no satisfactory and scientifically reliable compilation of the principle sources has previously existed. Contemporary collections of international law documents contain those laws currently in effect, but omit historical documents. This gap is now filled with the publication of *Fontes Historiae Iuris Gentium*. This three-volume work covers historical developments from antiquity to the end of World War II. Original documents are reproduced and followed by a translation in both English and German, when the original document is not in either language.

The documents, or parts thereof, presented in these volumes have been selected from the enormity of material available by Wilhelm Grewe, whose widely acclaimed work, *Epochen der Völkerrechtsgeschichte* (Epochs of the History of the Law of Nations), published in 1984, forms the theoretical basis on which the present work is organized.
