The area of coverage of the *Journal* includes China, Japan, Korea and Southeast Asia; the subject matter, history, geography, fine arts, language, literature, philosophy, architecture, archaeology, economics, political science, sociology, and anthropology. The *Journal* will normally be published in English and Chinese, but the Editors will be pleased to consider contributions in other languages. Articles in languages other than English must be accompanied by an abstract in English. Manuscripts not in Chinese must be typed in double spacing on single sides of quarto paper, and should be accompanied by a brief biographical note about the author. Footnotes should appear at the end of typescript articles. Contributors receive 25 offprints of their articles.

## CONTRIBUTORS TO THIS ISSUE

LOUIS GOLOMB is a Ph.D candidate in Anthropology at Stanford University, from which he obtained his M.A. degree. His article stems from two years' experience as a U.S. Peace Corps teacher in Thailand and three months of field-work in Chiangmai.

JAMES ANSIL RAMSAY is Associate Professor of Government at St. Lawrence University in Canton, New York. He holds a Ph.D from Cornell University. His current research interest is the emerging rural-urban gap in Thailand and its political implications.
