**JEFFERY M. PAIGE** is Professor of Sociology and Director of the Center for Research on Social Organizations at the University of Michigan. He has written extensively on the comparative study of revolutions and is currently working on a book on the role of the coffee elites in El Salvador, Costa Rica, and Nicaragua during the Central American crisis of the 1980s.

MARK THURNER is Assistant Professor of History at the University of Florida.

**JOHN CHARLES CHASTEEN** is an assistant professor at the University of North Carolina at Chapel Hill. His contributions to a new cultural history of Latin America include articles on ninteenth-century social behavior in Latin America. **HERNAN VIDAL** is Professor of Latin American Literature and Comparative Studies in Discourse and Society at the University of Minnesota.

**WALTER D. MIGNOLO** is Professor in Romance Studies and the Graduate Program in Literature at Duke University. His work on colonial and postcolonial discourses includes The Darker Side of the Renaissance: Literacy, Territoriality, and Colonization, and two edited works, The Americas: Loci of Enunciation and Imaginary Construction and Writing without Words: Literacies in Mesoamerica and the Andes, the latter coedited with Elizabeth Hill Boone.

**ROLENA ADORNO** *teaches Spanish American literary and cultural history at Princeton University, where she is a professor in the Department of Romance Languages and Literatures. She recently coedited with Kenneth Andrien* Trans-Atlantic Encounters: Europeans and Andeans in the Sixteenth Century *and wrote a critical introduction for a new edition of Irving Leonard's* Book of the Brave.

**PATRICIA SEED** is currently completing a comparative history of European colonization and military conquest of the New World that will consider English, Spanish, French, Portuguese, and Dutch forms of colonialism. The introduction to this project, "Taking Possession and Reading Texts: Establishing the Authority of Overseas Empires," appeared in the William and Mary Quarterly in 1992 and won that journal's prize for best article of the year.

**BARBARA TEDLOCK** is a professor of anthropology at SUNY Buffalo who specializes in the history and ethnography of the Maya. In 1993 she received a fellowship from the National Endowment for the Humanities and a grant-in-aid from the American Council of Learned Societies to translate, interpret, and publish a major eighteenth-century Mayan calendrical document known as the "Quiché Codes."

**SUSAN E. RAMIREZ** is Professor of History and Director of the Latin American Studies Program at De Paul University in Chicago. Her research interests include colonial Latin American social and economic history and Andean ethnohistory.

MARINA A. OBOROTOVA is a Senior Research Fellow at the Institute of World Economy and International Relations in Moscow. Specializing in U.S. and Russian policies in Latin America, she wrote The United States and Latin America, 1977–1988 (Moscow: Nauka, 1989) as well as numerous articles.
