This new edition covers the immense changes which have taken place in the legal sphere in Africa during the last decade: the general disappearance of native courts, the integration of judicial systems and the revision of the final appeals system. It brings up to date the information contained in the first edition of 1962 and describes the judicial and legal systems of selected African countries as they stand towards the end of the 1960's.

The work follows in general the pattern of the first edition, the principal variation being the inclusion of more detailed accounts of the legal systems which form the basis of the courts' work, a subject touched on only briefly in the original work.

The main object of this book is to present a factual account of the different methods of qualifying as a lawyer in East Africa. In achieving this the author provides invaluable practical advice on all aspects of a legal career in East Africa, beginning with the decision to study law, continuing through information on entrance to and work at the centres for law study, the qualifications, and careers generally. Reference is made to relevant syllabuses, courses, and textbooks, with particular attention being devoted to East African textbooks and legal periodicals. Information is also given about the various training courses for non-professional magistrates, the entrance requirements, and the form which the courses take.

The history, structure and works of the main law teaching centres, the Faculty of Law at University College, Dar es Salaam, the Kenya School of Law, Nairobi, the Uganda Law Developments Centre and the Department of Law at University College, Nairobi, are all explained in full and details are given of necessary addresses, fees, preliminary qualifications and so on. The section dealing with careers for lawyers in East Africa covers most helpfully public services, private practice, local government, teaching, and commerce and industry. In total, this book will answer effectively almost every question which could be put by the student on the subject of beginning a legal career in East Africa, on achieving his qualifications and on the development of the career itself later on.

The book is divided into four main parts. Part I deals with the methods of qualifying as an advocate in East Africa. Part II deals with the different courses for training lay-magistrates. Part III deals with textbooks. Part IV deals with careers for lawyers in East Africa.
