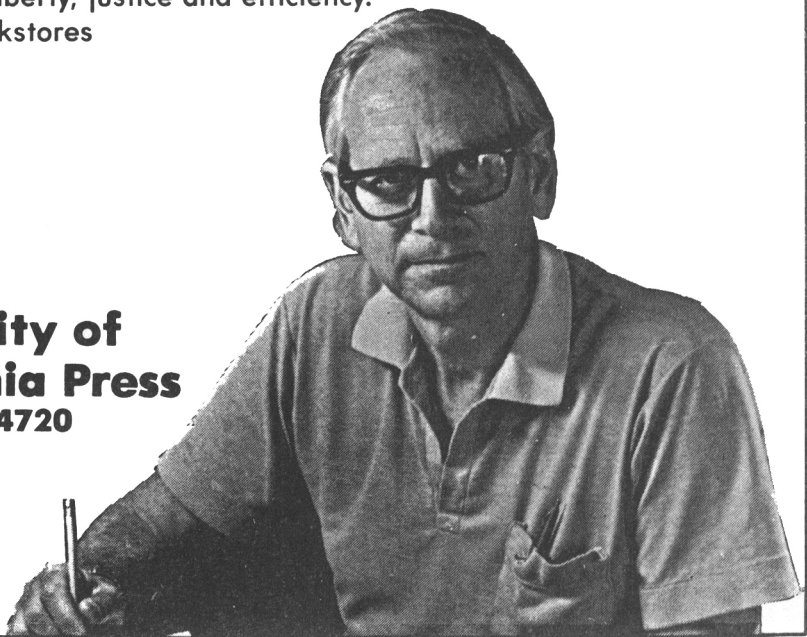
A PREFACE TO ECONOMIC DEMOCRACY

Tocqueville pessimistically predicted that liberty and equality would be incompatible ideals. Robert Dahl, author of the classic *A Preface to Democratic Theory* understands this worry but believes that we can avoid Tocqueville's dilemma.
