

According to the author, the conflict is characterized by absolute positions, a feature that has escaped the attention of many commentators and the public. Such positions are autonomous and not derived from the rival's position; thus, they are not influenced by changes in the rival's positions or by its promises. The Arab position had been absolute in its call for the destruction of Israel; now the official Israeli position, which calls for Israel to retain all of the occupied territories and the settlements, is absolute. The article then reviews changes in the adversaries' positions and discusses the role of the United States and the effects of the Iraqi war. The author concludes with an analysis of the present circumstance and the possibilities of a move toward negotiations to resolve the conflict.
