Priscillian of Avila led an evangelical movement in the fourth-century churches of Spain and Aquitaine, which called for spiritual discipline and alertness to the unexpected and the non-rational. Charged by a brother bishop with sorcery, lechery, and Manicheism, he was tortured and executed in A.D. 385. The analysis of the social pressures leading to the tragedy makes alarmingly contemporary reading. £5.50

Both in subject and in method, Alan Gilbert's book is an important contribution to English social history: it is the first general historical study to cover the sociology of English religion across the whole of the vital period from the early eighteenth century to the twentieth. It is also the first study of its kind to apply, on a systematic basis, quantification and simple statistical techniques to the conventional forms of historical evidence in this area.

Throughout, Dr Gilbert analyses religious practice as an aspect of social behaviour influenced by political orientation, recreational needs and socio-economic status. Religious trends thus emerge, not in artificial isolation, but in their natural context as an integrated part of the larger process of social change.

This book will be welcomed by all students of English social history; and ecclesiastical historians will also find in it a valuable complement, and context, to the traditional concerns.

It is the first volume to be published in a major series of *Themes in British Social History*, under the editorship of Dr John Stevenson.

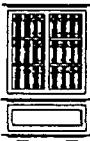
