Agnes Akosua Aidoo is an Assistant Professor of African History at the University of California, Los Angeles. She has taught as a Lecturer in History at the University of Cape Coast, Ghana. Her research done mainly in England and Ghana has been on social and political change in the Asante empire, the role of queen mothers in Asante society and politics, and the colonial education of women in Ghana. She is completing a monograph, "An Empire in Crisis: Asante, 1867-1900," based on her 1975 Ph.D. dissertation. She is also working on a manuscript of a collective biography of Asante queen mothers from 1700 to 1900. Following an invitation from the Catholic Archbishop of Ghana, she is researching and preparing a textbook on the history of the Catholic Church in Ghana for schools and colleges.

Edward H. Berman is Associate Professor of Comparative Education at the University of Louisville. His most recent publication is *African Reactions to Missionary Education* (Teachers College Press, 1975).

Emmit B. Evans, Jr. holds a Ph.D. in political science from the University of California, Berkeley. Specializing in comparative Third World studies, he is presently writing up the results of research that he recently completed in Mexico on the social and political roles of the natural and the social sciences in processes of socio-political change.

Jeffrey A. Fadiman is an Associate Professor of African History at Eastern Michigan University. He specializes in studies of East African witchcraft and has spent fifteen months researching the supernatural belief systems of the Meru of Mt. Kenya. His most recent publication is *Mountain Warriors* (Ohio University, Center for International Studies, 1976).
