Carol M. Rose is Lohse Chair for Water and Natural Resource Law at the University of Arizona Rogers College of Law, and Gordon Bradford Tweedy Professor of Law and Organization at Yale Law School (*Emerita*). Her research focuses on the history and theory of property, and on the relationships between property and environmental law. Her writings include two books, *Property and Persuasion* (1994) and *Perspectives on Property Law* (3d ed., 2002, with R. C. Ellickson and B. A. Ackerman), and numerous articles on traditional and modern property regimes, environmental law, natural resource law, and intellectual property. She holds degrees from Antioch College (B.A. in philosophy), the University of Chicago (M.A. in political science, and J.D.), and Cornell University (Ph.D. in history), and an honorary degree from the Chicago Kent College of Law. She is a member of the American Academy of Arts and Sciences and is on the board of editors of the Foundation Press.

Mark Sagoff directs the Institute for Philosophy and Public Policy in the School of Public Policy at the University of Maryland. He holds an A.B. from Harvard University and a Ph.D. in philosophy from the University of Rochester, and has taught at Princeton University, the University of Pennsylvania, the University of Wisconsin–Madison, and Cornell University. He has published widely in journals of law, philosophy, and the environment, and his most recent books are *Price, Principle, and the Environment* (2004) and *The Economy of the Earth* (2d ed., 2008). He was named a Pew Scholar in Conservation and the Environment in 1991 and was awarded a fellowship at the Woodrow Wilson International Center for Scholars in 1998. He is a fellow of the American Association for the Advancement of Science and of the Hastings Center.

Andrew P. Morriss is H. Ross and Helen Workman Professor of Law and Professor of Business at the University of Illinois. He is also a research fellow of the New York University Center for Labor and Employment Law; a senior fellow of the Property and Environment Research Center in Bozeman, Montana; a senior scholar of the Mercatus Center at George Mason University; a senior fellow of the Institute for Energy Research in Houston; and a regular visiting professor at Universidad Francisco Marroquín in Guatemala. He previously served as Galen J. Roush Professor of Business Law and Regulation at Case Western Reserve University, where he was also associate dean from 2000 to 2003. He is the coauthor, with Bruce Yandle and Andrew Dorchak, of *Regulation by Litigation* (2008), and

of many scholarly essays. He is the coeditor of *Cross-Border Human Resources, Labor, and Employment Issues: Proceedings of the New York University 54th Annual Conference on Labor* (2004), *Property Stories* (2004), and *The Common Law and the Environment* (2000).

John Hasnas is Associate Professor at Georgetown University's McDonough School of Business, where he teaches courses in ethics and law. He is also a senior research fellow at the Cato Institute and an associated member of the Kennedy Institute of Ethics. He has held previous appointments as Associate Professor of Law at George Mason University School of Law and as Law and Humanities Fellow at Temple University School of Law, and has served as a Visiting Associate Professor of Law at Georgetown University Law Center, Duke University School of Law, and the Washington College of Law at American University. He received his B.A. in philosophy from Lafayette College, his J.D. and Ph.D. in legal philosophy from Duke University, and his LL.M. in legal education from Temple Law School. Between 1997 and 1999, he served as assistant general counsel to Koch Industries, Inc., in Wichita, Kansas.

A. H. Barnett is Professor of Economics at the American University of Sharjah and Emeritus Professor of Economics at Auburn University. His work on environmental economics in general, and externalities in particular, spans thirty-five years and has been published in a number of journals and collections. His work on externalities has appeared in such publications as *The American Economic Review*, *Duke Environmental Law and Policy Forum*, *Southern Economic Journal*, *Review of Regional Studies*, *Public Finance Review*, *Journal of Regulatory Economics*, and *The Electricity Journal*.

Bruce Yandle is Alumni Distinguished Professor of Economics Emeritus at Clemson University. He is also a senior fellow with the Property and Environment Research Center in Bozeman, Montana, and an editorial board member of the *European Journal of Law and Economics*. His authored and edited books include *The Political Limits of Environmental Quality Regulation* (1989); *Taking the Environment Seriously* (1993); *Land Rights: The 1990s Property Rights Rebellion* (1995); *Common Sense and Common Law for the Environment* (1997); *Agricultural Policy and the Environment* (2003); and *Regulation by Litigation* (2008). His research focuses on environmental policy and regulation.

Andrew Dobson is Professor of Politics at Keele University, United Kingdom. He specializes in environmental political theory. Among his publications are *Green Political Thought* (4th ed., 2006), *Justice and the Environment* (1998), and *Citizenship and the Environment* (2003). He was a founding editor of the international journal *Environmental Politics*.

Charles T. Rubin is Associate Professor of Political Science at Duquesne University and a member of the graduate faculty in Duquesne's Graduate Center for Social and Public Policy. He is the author of *The Green Crusade: Rethinking the Roots of Environmentalism* (1994) and the editor of *Conservation Reconsidered: Nature, Virtue, and American Liberal Democracy* (2000).

Michael E. Mann is Associate Professor in the Departments of Meteorology and Geosciences at Penn State University, and Director of Penn State's Earth System Science Center (ESSC). He received his undergraduate degrees in physics and applied mathematics from the University of California at Berkeley, an M.S. degree in physics from Yale University, and a Ph.D. in geology and geophysics from Yale University. His current areas of research include model/data comparisons aimed at understanding the long-term behavior of the climate. He was a lead author of the Intergovernmental Panel on Climate Change (IPCC) Third Scientific Assessment Report. He received the outstanding scientific publication award for 2000 from the National Oceanic and Atmospheric Association, and in 2002 was selected as one of the fifty leading visionaries in science and technology by *Scientific American*. He is the author of more than a hundred peer-reviewed and edited publications, and recently coauthored the book *Dire Predictions: Understanding Global Warming* (2008) with colleague Lee Kump.

John David Lewis is Visiting Associate Professor of Political Science at Duke University. He received his Ph.D. in classics from the University of Cambridge. He has been a senior research scholar at the Social Philosophy and Policy Center, Bowling Green State University, and has published articles in journals such as *Polis*, *Dikē*, and *Bryn Mawr Classical Review*. His books include *Solon the Thinker: Political Thought in Archaic Athens* (2006) and *Early Greek Lawgivers* (2007).

J. R. Clark is Probasco Chair of Free Enterprise at the University of Tennessee at Chattanooga. He earned a Ph.D. in economics from Virginia Polytechnic Institute. He is the author or coauthor of six books and numerous academic articles, and was previously a research fellow at Princeton University and a distinguished visiting scholar at Moscow State University in Russia. He is a past president of the Association of Private Enterprise Education and currently serves as secretary/treasurer for both the Southern Economic Association and the Association of Private Enterprise Education. His research has ranged from traditional public finance and public choice topics to public policy in the areas of prison sentencing, education, taxation, regulation, welfare, and environmental policy.

Dwight R. Lee is William J. O'Neil Professor of Global Markets and Freedom at Southern Methodist University in Dallas. He has held full-time tenured faculty appointments at the University of Colorado, Virginia

Tech University, George Mason University, and the University of Georgia, where he was Ramsey Professor of Economics and Private Enterprise from 1985 to 2008. He received his Ph.D from the University of California, San Diego, in 1972. His research has covered a variety of areas, including the economics of the environment and natural resources, the economics of political decision-making, public finance, law and economics, and labor economics. He has published more than 130 articles in academic journals and has coauthored eleven books. He was president of the Association of Private Enterprise Education from 1994 to 1995 and president of the Southern Economic Association from 1997 to 1998.

Jonathan H. Adler is Professor of Law and Director of the Center for Business Law and Regulation at Case Western Reserve University School of Law. His edited books include *The Costs of Kyoto: Climate Change Policy and Its Implications* (1998), and *Ecology, Liberty, and Property: A Free-Market Environmental Reader* (2000). He received a B.A. *magna cum laude* from Yale University, and a J.D. *summa cum laude* from the George Mason University School of Law.

J. Baird Callicott is Regents Professor of Philosophy and Chair of the Department of Philosophy and Religion Studies at the University of North Texas. He is the co-editor-in-chief of the *Encyclopedia of Environmental Ethics and Philosophy* (2008) and the author or editor of a number of books and journal articles in environmental philosophy and ethics. He has served as president of the International Society for Environmental Ethics and as bioethicist in residence at Yale University. His research goes forward simultaneously on four main fronts: theoretical environmental ethics; comparative environmental ethics and philosophy; the philosophy of ecology and conservation policy; and biocomplexity in the environment. He is perhaps best known as the leading contemporary exponent of Aldo Leopold's land ethic and is currently exploring an Aldo Leopold Earth ethic in response to global climate change.

William Grove-Fanning is a doctoral student in the Department of Philosophy and Religion Studies at the University of North Texas. He holds an M.A. in philosophy from San Francisco State University. Prior to entering academia, he was a professional chef for more than twenty years, the last ten in San Francisco. His current research interests are in environmental philosophy and ethics, and the integration of ecological theory.

N. Scott Arnold is Professor of Philosophy at the University of Alabama at Birmingham, where he has taught since 1982. He is the author of *Marx's Radical Critique of Capitalist Society* (1990), and *The Philosophy and Economics of Market Socialism* (1994). His latest book, *Imposing Values: An Essay on*
