Broadly comparative, *Desperate Magic* by Valerie Kivelson is the first sustained study of seventeenth-century Russian witch trials. The book uses trial evidence to illuminate some of the central puzzles of Muscovite history. The routine use of torture in extracting and shaping confessions raises methodological and moral questions with continuing resonance in the world today.

Merab Mamardashvili and Russian Cinema




The Man Who Brought Brodsky into English Conversations with George L. Kline
