The book for the year 1892-93 is as announced in last year's Report— THE ACCOUNTS OF HENRY EARL OF DERBY. Edited by Miss TOULMIN SMITH.

The Council had hoped that this book would have been in the hands of Members before the Annual Meeting. It has, however, been a work of much labour, necessitating a good deal of correspondence with Germany, where the East and West Prussian Historical Society have undertaken to publish, simultaneously with the issue of the whole work by this Society, an edition of so much of it as concerns Prussia. Nevertheless there is every reason to expect that it will now be issued without much further delay.

For the year 1893-94 it is impossible to promise absolutely more than one volume, which will be a volume of Miscellany, containing, among other matters, Wentworth and (additional) Hamilton Papers, and a collection of Woodcuts illustrating rare ballad broadsides in the time of the Stuarts. It is a matter of much regret to the Council that the present resources of the Society do not enable them to present Members with a greater number of issues in return for their Subscriptions. An appeal to Libraries and Institutions has resulted in a small addition to the number of Subscribers; but the Council would urge all Members of this Society who have influence with such Institutions to press on their Committees the importance of giving their support to the Society.

The Council much regret that "The Accounts of the Earl of Derby," the volume for the year 1892-3, has not yet been published. The delay, for which the Editor offers sincere apologies, has been entirely due to the unexpected amount of labour involved in its production, and it is hoped that the work, which has been so serious a task upon her energies, will be of special value in consequence. The difficulties in making out the itineraries, in consequence of the conflicting dates given in the MS., have been considerable, and the work of identifying the place-names has been no less troublesome. Care had to be taken in drawing up indices of persons and places especially, as but slight clues were sometimes offered. The introduction left by Dr. Pauli at his lamented death was imperfect and inadequate, whilst several of the positions adopted by Professor Prutz seemed to require re-investigation. It is now expected that the Volume will be out of the Editor's hands by the end of May.

The CAMDEN was the first Society established on the popular principle which has since been so widely adopted. It was instituted to perpetuate, and render accessible, whatever is valuable, but hitherto little known, amongst the materials for the Civil, Ecclesiastical, or Literary History of the United Kingdom; and it accomplishes that object by the publication of Historical Documents, Letters, Ancient Poems, and whatever else lies within the compass of its design, in the most convenient form, and at the least possible expense consistent with the production of useful volumes.

The ground occupied by the Camden Society is totally distinct from that which of late years has been taken up by the series of Chronicles and

Documents published under the superintendence of the Master of the Rolls. These publications are limited to a period ending with the reign of Henry the Seventh; whereas the Camden Society, though it will still continue to make use of any documents which, from any reason, are not suitable for the Rolls series, will find its principal work in the unpublished matter relating to the history of our country during the sixteenth, seventeenth, and eighteenth centuries, which is of so varied and interesting a character.

The Subscription of Members is £1 per annum, which becomes due in advance on the first day of May in every year, and is received by the Treasurer, J. J. CARTWRIGHT, Esq., Rolls House, Chancery Lane, W.C.; in return for which the Subscriber receives as many volumes as the Society's funds will enable them to issue during the year.
