## WITTGENSTEIN'S LOGICAL ATOMISM

---

by J. P. GRIFFIN. This book is a study of the central philosophical topics of Wittgenstein's *Tractatus Logico-Philosophicus*: objects, substances, states of affairs, elementary propositions, pictures and thoughts. The author's aim is to understand Wittgenstein's programme of analysis—why is analysis necessary? how does it work? where does it end? Understanding the *Tractatus*, he thinks, depends upon adequate answers to these questions. He decides that analysis is reduction to what is basic not in experience but in reference, and that, contrary to the established interpretation, the *Tractatus* is concerned not with problems of knowledge but with problems of sense. ## HUMAN ACTS

---

*An Essay in Their Moral Evaluation*, by ERIC D'ARCY. This is a study of the several elements of a human act which are relevant to its characterization in human discourse, and to its moral evaluation. Bentham suggested that the elements to be considered were the motive, the consequences, and the circumstances, especially those of intentionality and consciousness. The author takes Bentham's treatment of the problem as his starting-point, although his method and his conclusions are considerably different. He looks for some of the assumptions about acts, and some of the rules for their moral evaluation, which are present or implicit in our day-to-day discussions and appraisals of human action and behaviour. ## MEINONG'S THEORY OF OBJECTS AND VALUES

---

by J. N. FINDLAY. This is the second edition of a study of the 'Theory of Objects' (or objectivist theory of logical categories) put forward by Alexis Meinong, which had a considerable influence on the thought of Russell, Moore, Broad, Ryle, Kneale, and other philosophers, both British and American. It contains additional chapters on Meinong's significant theory of value, and a general appraisal of this work in relation to contemporary thought. (\$6.50)
