#### CALENDAR OF MEETINGS

AID Seminars on Social and Economic Development—Peru, August 2–20, 1965 USIS-Peru, under the leadership of Frederick J. Bancroft, programmed three USAID-financed

seminars on social and economic development within the framework of the Alliance for Progress. United States government representatives, Fulbright personnel, and Peruvian development specialists participated in the seminars.

International Symposium on Marketing for Economic Growth—Washington, D.C., September 1–3, 1965

Papers with a Latin American content were read in several sections at this meeting: A Theory of Marketing Development: Mexico

by Douglas Felix Lamont, University of Richmond; The Role of the Government in the Promotion of Efficiency in the Retail Marketing of Food Products in Greater Santiago, Chile, by Peter D. Bennett, Pennsylvania State University; Marketing in Brazil by Donald A. Taylor, Michigan State University; An Inquiry into Product Bias and Predilection within the Central American Common Market by Robert D. Schooler, University of Missouri; Marketing in Latin America by Vergil D. Reed, American University; The Role of Food Marketing in Latin American Economic Development by Charles C. Slater, Michigan State University.

Annual Meeting of Directors of Development Research and Training Institutes—Naples, September 16–21, 1965 Participants in the sessions at the Centre for Advanced Training and Research in Agricultural Economics heard the following presentations on specifically Latin

American topics: Development Research Problems in Latin America by Miguel S. Wionczek, CEMLA, Mexico City; A Joint Research Project on Industrial Integration in Latin America by Joseph Grunwald, The Brookings Institution; and The Economic Development Training Requirements, As Seen from the

Point of View of Development Institutions, the late Jorge Ahumada, CENDES, Venezuela; The Development Centre of the Organisation for Economic Cooperation and Development sponsored the meeting under the direction of François van Hoek, head of the Training and Co-operation Division. A publication containing the amended papers and summaries of discussions was to be published in late spring 1966 by the OECD Development Centre, 19, boulevard Exelmans, Paris-XVIe, France.

Inter-American Council Meeting Washington, D.C., October 1, 1965

At the first 1965-66 meeting at American University, Jiri Nehnevajsa, University of Pittsburgh,

spoke on Images of Colombia: 1970. The topic was based on a study conducted in Colombia in 1964–65.

Seminar on Juridical and Institutional Aspects of LAFTA—Montevideo, October 18–23, 1965 Western hemisphere international law scholars participating in the meeting examined three major topics pertaining to the theme: 1)

Institutional Aspects—structure, functions, and attributes of LAFTA organs; possible structures of a Latin American common market; the processes of Latin American integration and the inter-American system; 2) Juridical Aspects—the necessity of unifying and harmonizing the juridical order of the member countries of LAFTA; and 3) International Cooperation on the Subject of Studies of Integration. Spanish, Portuguese, and Latin American Studies in Great Britain Oxford, October 23, 1965

Prospects in the United Kingdom for Spanish, Portuguese, and Latin American studies in the light of the recommendations of

the Parry Report on Latin American Studies was the subject of this conference at the Oxford Institute of Education. Some 60 persons representing ten universities in the United Kingdom, the Association of Teachers of Spanish and Portuguese, and some of the leading technical colleges heard five speakers discuss various aspects of the topic. John Walker, director general of Canning House, reviewed British relations, historic and current, with Spain, Portugal, and the Latin American republics, stressing the growing interest in pursuing business careers in Latin America. Raymond Carr, director of Latin American Studies and fellow of St. Antony's College, Oxford, discussed the intellectual justification for Latin American studies and the challenges of developing interdisciplinary programs. D. C. Riddy, Department of Education and Science,

dealt with the technical problems of stimulating the study of Spanish and Portuguese in secondary schools. The possibility of developing university centers of Latin American studies in the technical colleges was encouraged by H. I. Baker, Department of Education and Science, J. H. Street, fellow of Fitzwilliam House, Cambridge, who served on the Parry Committee, discussed the purpose of establishing centers of Latin American studies within the context of universities.

Meeting on the Teaching of Juridical and Institutional Problems of Latin American Integration—Buenos Aires, October 25–30, 1965 Professors and specialists in international law and from Latin America, the United States, and Europe met in Buenos Aires under the auspices of the Inter-

American Institute of International Legal Studies to elaborate a scheme for the investigation and teaching of the juridical and institutional problems of Latin American integration. The scheme was developed for use by Latin American faculties of law and political science and of economics. 2nd Special Meeting on the Juridical and Institutional Aspects of Foreign Private Investment—Rio de Janeiro, November 1–6, 1965 International legal scholars from the Western Hemisphere gathered to discuss the juridical and institutional aspects of foreign private investment. Program top-

Tercera Mesa de Estudio de la Preparación de los Bibliotecarios en América Latina—Medellín, Colombia, November 1-15, 1965 This reunion at the Escuela Interamericana de Bibliotecología, Universidad de Antioquia represented the final step in a threeyear plan for the study of the

preparation of Latin American librarians. Ten leading librarians and directors of library schools from Argentina, Brazil, Chile, Colombia, Mexico, Peru, Puerto Rico, Venezuela, and the United States participated in the deliberations. Plans have been made to publish the results and documents from the project in five volumes before July 1966. Inter-American Council Meeting Washington, D.C., November 9, 1965 John Plank, director of political development studies, Foreign Policy Studies Division, The Brook-

ings Institution, reported to the Council meeting on his recent trip under the Fulbright program to Chile, Peru, and Colombia.

35th Annual Meeting of Southern Economic Association—Miami Beach, November 11–13, 1965 Several papers with Latin American content were on the program at this annual convocation. Robert S. Smith, Duke University, spoke

on Aid to Latin America in Historical Perspective; Eric N. Baklanoff, Louisiana State University, on Nationalism and Mineral Development: The Political Economy of Chile's La Gran Mineria de Cobre; Mostafa F. Hassan, University of Miami, on the Second Four-Year Plan of Venezuela; Raul Branco, The University of Texas, on Land Reform: The Answer to Latin American Agricultural Development?; and Harry Stark, University of Miami, on Economic Integration in Latin America.

16th National Congress of Sociology Veracruz, November 22–26, 1965 Sociology of Conflict and Cooperation, the congress theme, received the attention of 180 schol-

ars from 11 Latin American nations, the United States, and France. Approximately 100 papers were presented in the sectional sessions and 17 in the plenary sessions. The Asociación Mexicana de Sociología and the Instituto de Investigaciones Sociales of UNAM convened the meeting under the auspices of the state government, municipal government, and the Universidad de Veracruz. Inter-American Council Meeting Washington, D.C., December 9, 1965

Gathering at Howard University, the Inter-American Council heard Howard Cline of the Hispanic

Foundation give a summary of the history of organizations that have existed in the field of Latin American studies. He discussed the efforts that have been made to facilitate communication of information among Latin Americanists, noting the most recent initiatives of the LARR and the consideration being given to a society of Latin Americanists. Bryce Wood of the Social Science Research Council (SSRC) elaborated further on this contemplated society and reviewed the activities of the Joint Committee on Latin American studies of the SSRC and the ACLS. The Council adopted a motion that it act as a clearing

house to gather information on officers and activities of other Councils in the U.S. for consideration and possible inclusion in the LARR.

Seminar on the Study of Sociology and Politics—Salvador, December 11–12, 1965

Latin American sociologists met at the Escola de Sociologia e Política da Bahia to compile, discuss,

systematize, and communicate ideas, technical teaching, and experiences on sociology and political science. Presentations dealt with the following topics: The Teaching of Sociology and Political Science by Francisco S. Céspedes, PAU; Sociology and Development by Manuel Diégues Júnior, director of CENTRO; Research in Political Science by Adriano G. Carmona Romay, Universidad del Zulia, Venezuela; Professionalization of Sociology by Brito Velho, Brazilian Deputy. Beatriz Dalurzo, Universidad de La Plata, Argentina, who presided over the sessions, lectured on the University of the Americas, and Waldemar Lopes, director of OAS in Brazil, spoke on M.A. Teixeira de Freitas and His Contribution to the Study of Social Sciences. Yves de Oliveira organized the seminar.

2nd Interamerican Meeting on Development Administration—Recife, December 13–18, 1965 Seventy-nine experts in the social sciences and public administration from 15 American countries met to participate in a seminar on re-

gional planning and a symposium on human resources. In the seminar on regional planning, delegates considered regional planning as a "tool" for development administration; regional planning and government policy; and regional planning as a systematic strategy of social and economic change, e.g., the Brazilian Northeastern case and others. Subjects discussed in the symposium on human resources were education and training on the national and inter-American levels; prevision; and social mobility. The Escola Interamericano de Administração Pública and the Superintendência do Desenvolvimento do Nordeste (SUDENE) sponsored the meeting, which was organized by Luiz Alves de Mattos, director of the EIAP. Proceedings from the sessions will be published as Annals of the II Meeting by EIAP/FGV, Rio de Janeiro, 1966.

Conference on Problems of the Agrarian Structure in Latin America—Berlin, December 13–19, 1965 The Deutsche Stiftung für Entwicklungsländer, in collaboration with the FAO, convened this conference. Subjects of attention were

the social implications of agrarian structures, discussed on the basis of two presentations by H. Kötter and Richard F. Behrendt; present and future action in various Latin American countries; agricultural cooperatives as useful instruments in agrarian reform; colonization and its role in the improvement of the

agrarian structure; agricultural credit and the access that *minifundistas* and *latifundistas* have to it; and the role that policy on the agrarian structure plays in economic development. Among the Latin Americans invited to participate were S. G. Brieger, J. Chonchol-Chait, J. C. Colloarte, O. Fals-Borda, Edmundo Flores, Rodolfo G. Franks, J. Gonçalves de Souza; Marco R. Isla, Carlos A. Medina, G. Mendoza, S. Rueda-Reyes, Javier G. Del Solar, R. Stavenhagen, J. Vidal-Perdomo, A. Vivanco, and Fernando Suárez de Castro.

Conference on Race and Class in Latin America During the National Period New York City, December 16–18, 1965

Cornell and Columbia Universities jointly sponsored and organized the conference at Columbia as part of the Cornell Latin Amer-

ican Year (CLAY). Magnus Mörner, visiting professor of Latin American history at Columbia, was the conference director. Of the 55 persons attending, 24 were contributing participants representing disciplines in the social sciences from universities in Brazil, Mexico, Peru, Sweden, Uruguay, and the United States; 31 additional scholars invited to attend the sessions came from universities in the countries listed as well as from Argentina, Colombia, and Spain. Reports and papers were presented in six sessions dealing with the following topics: Historical Demography and Ethnical Classification; the Abolition of Negro Slavery and the Absorption of the Negro into Society; Immigration and Race Relations; Evolution of Social Stratification and Social Attitudes in the Indo-American Area; and Twentieth Century Indigenismo and Socio-Racial Attitudes. Sessions were not open to the general public, but proceedings of the conference are to be published by the Cornell University Press. The volume will appear in English and include the reports, papers, and a resumé of the discussions.

Conference on Faculty Interchange Coordination—Mexico City, January 3-4, 1966

Representatives of six United States universities, the Foreign Area Fellowship Program (FAFP), and the SSRC attended

this conference held under the auspices of the FAFP (U.S.-Latin American Faculty Interchange Program). Schuyler C. Wallace, director of FAFP, was responsible for organizing the meeting. Significant conclusions and recommendations emerging from the discussions of U.S.-Latin American faculty interchange coordination were as follows: 1) It was recommended that a coordinating body, expanded beyond the current six-member Management Committee of the U.S.-Latin American Faculty Interchange Program, be brought into existence. This body might become a subcommittee of a new Latin American studies association, or, if the association is not formed, it could operate independently proved that a source of financial support could be found. 2) It was recommended that the improvement of Latin American studies in the

United States should continue to characterize the activities of the new coordinating group. 3) In the fall of 1966, a meeting should be held for the purpose of resolving the issues of organization and funding which were left suspended during the current session. Minutes of the conference were distributed by the FAFP in February 1966.

Inter-American Council Meeting Washington, D.C., January 10, 1966

Population Problems in Latin America was the subject of discussion at this gathering. Ray-

mond B. Allen, director, Office of Research Coordination, Pan American Health Organization (PAHO), and Peter Ruderman, health economist, PAHO/WHO, discussed the work in process on population questions in Latin America.

Meeting of Inter-American Cultural Council—Washington, D.C., January 18–25, 1966

The fourth meeting of the Inter-American Cultural Council was held at the Pan American Union in Washington, D.C. Among the

subjects considered were the evaluation, comparison, and financing of educational, scientific, technological, and cultural development. Persons addressing the conference on these and other subjects were Jose A. Mora, secretary general of the OAS, Daniel Arango, Minister of Education of Colombia and chairman of the Inter-American Cultural Council, and Jaime Posada, assistant secretary for Cultural, Scientific, and Informational Affairs of the OAS, who is also executive secretary of the Cultural Council. Delegates from 20 nations of the Western Hemisphere attended the meeting.

Meeting on Municipal Financing in Latin America—Washington, D.C., January 23–26, 1966 More than 150 persons attended this seminar sponsored by the Inter-American Development Bank (IDB) in collaboration with the

Inter-American Municipal Organization (IAMO). Sixty papers were presented on the subjects of municipal financing, municipal enterprises, national municipal associations, community development, the municipality and integration, technical assistance, Alliance for Progress and the municipalities, IDB financing for public works, and others. Workshop on Central American Urban Research—New Orleans, January 24, 1966 Reports of current research in the urban Central American social structure comprised this meeting at Tulane University. Richard

Adams and Michael Micklin were responsible for organizing the workshop,

which was sponsored by the University of Texas and Tulane. No formal papers were presented; instead discussion centered around completed research such as that on Nicaragua by Kay and Odin Toness, University of Illinois; on Guatemala by Michael Micklin, and on Mexico by Alvan Zarate, University of Texas; as well as around work in progress or to be initiated shortly such as the projects on Guatemala being conducted by Bryan Roberts, University of Manchester; Frederick Sixel, University of Bonn; Alvan Zarate; Michael Micklin; Leonard Reissmann, Tulane University, respectively; and on El Salvador by Alastair White, University of Texas. Topics included the Political Structure of Slums, Female Participation in the Labor Force, Urban Fertility Behavior, Urban Migration, and Theories of Urban Development.

CHEAR Inter-American Seminar on Demography and the University Antigua, January 30-February 2, 1966 Approximately 50 representatives of universities in the United States and Latin America as well as of inter-American and interna-

tional organizations concerned with demography attended this seminar in Guatemala, sponsored by CHEAR. The seminar discussions were informal and no papers were read. The following participants did make presentations on the subjects under discussion: Demography as a Discipline: Its Scope and Objectives by Philip Hauser, University of Chicago; Demography and its Applications in Planning by Jorge Arias, Universidad de San Carlos de Guatemala; The Status of Demographic Teaching in the Americas by Carmen Miró, Centro Latinoamericano de Demografía; The Status of Demographic Research in the Americas by J. Mayone Stycos, Cornell University; Demography and Economics by Luis Escobar, IMF; Demography and Public Health by Irene Taeuber, Princeton University; Demography and Sociology by Dudley Kirk, Population Council, New York; Demography and Education by Ignacio González, Universidad de Concepción, Chile. There were also two panel discussions on Planning a Curriculum in Demography, and on Demography and its Relationships with Other Academic Fields. Meeting of Experts on National Planning of Library Services in Latin America—Quito, February 7-14, 1966 Thirteen participants from Argentina, Brazil, Canada, Chile, Costa Rica, Ecuador, Mexico, Spain, the United States, United

Kingdom, and Uruguay gathered in Ecuador for this meeting. They attempted to define the proper role for libraries of all kinds in the over-all planning for educational, scientific, and cultural development in Latin American countries. UNESCO and the government of Ecuador cosponsored the meeting. The Division of Libraries, Documentation and Archives, UNESCO, and the National Commission for UNESCO, Ecuador, were responsible for the organizational details. A final report will appear in late 1966 in an issue of the *Unesco Bulletin for Libraries*.

Inter-American Council Meeting Washington, D.C., February 10, 1966 Civic Action in Latin America was the theme under which this meeting was convened at Catho-

lic University. Speakers were Neal Ronning, School of Advanced International Studies, Johns Hopkins University, and Willard Barber, University of Maryland.

International Conference on Christian Democracy—South Bend, February 11–13, 1966 Christian Democracy in Latin America was the subject of a number of presentations at this conference at the University of

Notre Dame: Christian Democratic Ideology in Latin America by John J. Kennedy, University of Notre Dame; Christian Democracy in Venezuela by Ramon Perez Febres, University de Los Andes, Venezuela; Christian Democracy and Technological Development by Hugo Perez La Salvia, former minister of development in the Betancourt administration; Christian Democracy and the Inter-American System by Alejandro Magnet, ambassador of Chile to the OAS; The Future of Bolivia—A Christian Democratic View by Benjamin Miguel, organizational secretary of the Bolivian Christian Democratic Party; Recent Christian Democratic Successes in Chile by Naudon de la Sotta, Chilean Christian Democratic figure; Christian Democracy in Brazil by Andre Franco Montoro, president, Christian Democratic Party of Brazil; The Christian Democratic Party in Paraguayan

Meeting of Society for Latin American Studies—London, February 19, 1966 Urbanization in Latin America was the theme of this annual meeting held at the London

Cornell participated in the CLAY seminar. Kalman Silvert, Dartmouth College, spoke on Cultural Integrity, Development and the Intellectual in Latin America; and Germain Arciniegas, Colombia, spoke on The Role of the Student in Latin American Development.

8th Annual Conference of CHEAR Caracas, February 27–March 4, 1966 Topics discussed at this meeting were The Responsibility of the University in the Conservation of

BIM/Hispanic and Luso-Brazilian Councils Joint Seminar on Brazil London, March 3, 1966 Senior executives in British enterprise attended this seminar at Canning House to appraise economic conditions and prospects in

Latin American Symposium on Industrial Development—Santiago, March 14–25, 1966 ECLA and the United Nations Centre for Industrial Development jointly organized the symposium. Representatives of Latin

American countries meet to study the existing situation, problems, and future prospects of industrial development for the region as a whole as well as for the individual Latin American countries. The two basic documents used for discussion were The Process of Industrial Development in Latin America and Los Principales Sectores de la Industria Latinoamericana: Problemas y Perspectivas. These documents, country reports, and studies submitted by the secretariat and other international or inter-American agencies were considered within five major categories: evaluation of industrialization in Latin America, and future outlook; present situation, problems and prospects of the main industrial sectors; problems relating to financing, exports and small industry; problems relating to the transfer of technical know-how, applied technological research and technical assistance; and the international symposium on industrial development (1967) and industrial development in Latin America. 4th Annual Meeting of Inter-American Economic and Social Council—Buenos Aires, March 15-April 1, 1966 Held at the expert and ministerial levels, this meeting involved delegates from 19 Latin American countries and the United States.

The theme, Socio-Economic Development of Latin America, was viewed from several perspectives: 1) examination of the first five years of the Alliance for Progress in its economic, social, and information aspects; 2) foreign trade and

international finance; 3) economic and social aspects of rural development. A number of sub-topics were considered under each of the major headings. The OAS sponsored the meeting, and Walter J. Sedwitz, IA-ECOSOC executive secretary, with the assistance of Cesar Orantes, Conference Division of PAU, was responsible for organizing the sessions. The Final Act of the meeting was published in Buenos Aires on April 1 and later in Washington, D.C., by the PAU. 8th World Congress of Society for International Development—New York City, March 16–18, 1966 Prospects for Accelerating Development in the Second Half of the Development Decade was the theme considered from a variety

of disciplinary perspectives at this congress. Delegates speaking to the congress from a Latin American orientation were Felipe Herrera, president, IDB, in the panel on Regional Development Banks; Eduardo Neira Alva, urban development consultant, IDB, in the workshop on Urban Problems in Urbanizing Countries; Pedro Iraneta, director, Economic and Social Development Division, IDB, and Felipe Pazos, Panel of Nine, Alliance for Progress, OAS, in the workshop on The State of the "Alliance for Progress."

13th Annual Conference of SECOLAS Coral Gables, March 18-19, 1966 The Southeastern Conference on Latin American studies held its 13th annual session at the Uni-

versity of Miami. Uruguay and Paraguay was the theme of deliberations. Papers presented included: Some Current Problems of Latin America with Special Emphasis on Uruguay and Paraguay by Robert W. Bradbury, University of Florida; The Economic Modernization of Uruguay: A Mixed Blessing by Herman E. Daly, Louisiana State University; Development of a Middle Latitude Culture in the Paraguayan Chaco by Anne Marie Krause, Southern Illinois University; Uruguay and Paraguay: Politics and Government Since World War II by Frederick E. Kidder, University of Puerto Rico; The Partido Revolucionario Febrerista: Paraguay's Left by Paul H. Lewis, Louisiana State University; Florencio Sánchez and His Social Consciousness of the River Plate Region by Manuel D. Simpósio Sobre a Biota Amazónica Belém, Brazil, June 6-11, 1966 The Association of Tropical Biology in collaboration with the Brazilian National Research

Council and other institutions organized this symposium on the Amazonia and tropical areas of the world with conditions similar to the Hylea. By April 1, 160 scientists concerned with the geosciences, anthropology, limnology, botany, zoology, pathology, and conservation of nature and natural resources had tentatively agreed to present lectures or contribute papers. This meeting, which was associated with the centennial commemoration of the Goeldi Museum in Belém, was the first to group the main biological sciences presently studied at the Amazon Basin and to include the geosciences. José Candido de Melo Carvalho, president of Museu Nacional, organized the sessions. Papers and commentary will be published in Atas Do Simpósio Sôbre a Biota Amazônica.

Seminar for Central America and Panama Tegucigalpa, Honduras, June 12–19, 1966 Population, Economic Development and Family Planning was the theme under discussion by ap-
