Hart, one of the world's most influential legal philosophers, is the first book in a new series, *JURISTS: PROFILES IN LEGAL THEORY*, devoted to eminent jurists and legal thinkers past and present. Hart is perhaps best known for his powerful philosophical arguments in favor of liberalizing criminal law and applying humane principles to punishment.
