INSTITUTIONAL CHANGE AND AMERICAN ECONOMIC GROWTH

LANCE E. DAVIS and DOUGLASS C. NORTH

Presents a model for examining problems of institutional change and applies it to American economic development in the 19th and 20th centuries.

Professors Davis and North argue that if external economic factors make an increase in income possible but not attainable within the existing institutional structure, new organizations must be developed to achieve the potential in income. Their model is designed to explain the type and timing of these changes.

The authors review the external causes of changes in American economic history over the past 175 years, and apply their model to land policy and agriculture, financial markets, transportation, manufacture, service industries and labor. \$10.95

SILVER MINING AND SOCIETY IN COLONIAL MEXICO, ZACATECAS 1546-1700

P. J. BAKEWELL

This study concentrates on Zacatecas, important as a powerful force in the domestic economy of Spanish Colonial Mexico and as a major supplier of bullion to the Spanish Crown.

Dr. Bakewell describes the discovery of the silver mines of Zacatecas, the establishment of the town, its role in the northward advance of the Spanish occupation, and the sources of its supplies of essential food and materials.

In his analysis of the mining industry of the district, he discusses techniques, labor and raw materials (mercury in particular), provides statistics for silver production, and explores sources of capital for the industry. (Cambridge Latin American Studies No. 15) \$13.50

PRIVATE INVESTMENT IN INDIA 1900-1939

AMIYA KUMAR BAGCHI

The author develops a simple theoretical framework and tries to isolate the influence on private investment in India of factor supplies as against demand conditions. All major manufacturing industries of the period 1900-1939 are studied in detail. Most of the analytical apparatus used is developed from orthodox economic theory, but emphasis is on Keynesian ideas.

Professor Bagchi presents a case study in the economic relations between an imperial power (Britain) and a dependent colony (India), examines the social relations between the British and the Indians, and provides a detailed account of the mechanics of imperialism.
