TRANSPORT COMPETITION AND PUBLIC POLICY IN CANADA by

DR. H. L. PURDY

Faculty of Commerce and Business Administration The University of British Columbia

This is the first book to examine contemporary forces of intermodal competition as they relate to the Canadian intercity transport picture. Against this background, it features an incisive discussion of federal transport regulation as implemented by the Canadian Transport Commission. Recent Canadian policy developments have been of considerable interest to transportation economists in other countries.

United States transportation observers may find of particular relevance the contrast between federal transport regulation in the U.S. and Canada. The rise of new competitors to the railways — motor carriers, airlines, and pipelines came later in Canada than in the U.S. The introduction of new modes in the U.S. had the effect of increasing the scope of public regulation; the reaction to these developments in Canada has tended towards deregulation. In the Canadian railway industry, for instance, extensive reliance is placed on the decision-making of private management working in competitive circumstances.

Canada's distinctive (and in the author's view more realistic) approach to the problem of rail line redundancy is another significant area of U.S.-Canada transportation policy contrast, detailed in the book. Abandonment of uneconomic freight and passenger lines is permitted when the railways prove a line is not paying its way, unless the Canadian Transport Commission rules that the resulting public inconvenience would be sufficiently great to justify its continuing to operate with the aid of a government subsidy. In the case of passenger line discontinuance, the Canadian method is in sharp contrast to the Amtrak policy of the U.S.
