

Die Beitrittsübereinkommen vom 9. Oktober 1978 und vom 25. Oktober 1982 mit Dänemark, Irland, dem Vereinigten Königreich und Griechenland wurden detailliert eingearbeitet. Gerade der Beitritt **Irlands** und des **Vereinigten Königreichs** (BGBl 1983 II 803; 1986 II 1020) bringt durch die epochale Annäherung kontinentaler und angelsächsischer Rechtssysteme eine **neue Dimension zwischenstaatlichen Rechtsverkehrs**. Aus diesem Grund ist im Anhang für die Praxis wichtige **Civil Jurisdiction and Judgements Act 1982** abgedruckt.
