The United States Institute of Peace (USIP) invites applications for Senior Fellowships for up to ten months as part of the Jennings Randolph (JR) Program for International Peace.

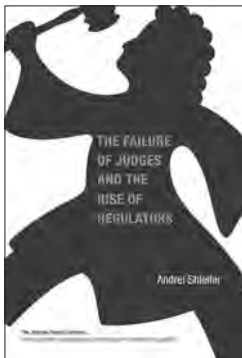
