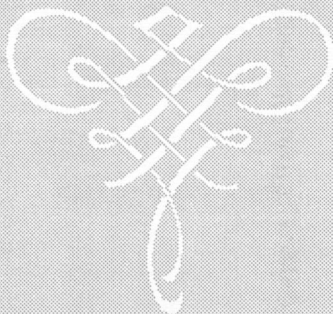

**T**he German Empire of 1871, although unified politically, remained deeply divided along religious lines. Helmut Walser Smith offers the first social, cultural, and political history of this division. He argues that Protestants and Catholics lived in different worlds, separated by an "invisible boundary" of culture, defined as a community of meaning.

As these worlds came into contact, they also came into conflict. The ongoing conflict, conditioned by a long history of mutual intolerance, was an integral part of the jagged and complex process by which Germany became a modern, secular, increasingly integrated nation.

What was the greatest catastrophe ever to befall the German countryside? When asked that question in a 1960s survey, a group of German villagers chose the Thirty Years' War by a wide margin. It was deemed worse than the Black Death and worse than the recent traumas of two World Wars. *German Villages in Crisis* is the most detailed study of how people in the countryside experienced that war. The book spans the period from 1580 to 1720 because the impact of the war cannot be understood by treating the years 1618 to 1648 in isolation.

This work is a major contribution to recent efforts to reconceptualize the themes and chronology of early modern German history. It also contributes to the broader debate about the relationship between rural life, warfare, and political power in early modern Europe.

Between 1575 and 1730, the citizens of the Alsatian Imperial city of Colmar were divided between Protestant and Catholic communities, plagued by chronic warfare, and ultimately subjugated by the kingdom of France. Using serial archival sources, Professor Wallace reconstructs the collective biography of 6700 civic officials, merchants, artisans, and agricultural workers in order to examine the local impact of confession-alization in a religiously mixed town, the effect of warfare on the economic interdependence of town and country, and the tensions between French absolutism and traditional civic political culture.
