The Contributors

DHANVEER SINGH BRAR is Andrew W. Mellon Postdoctoral Fellow in the Humanities at Penn Humanities Forum, University of Pennsylvania. He holds a PhD in media and communication from Goldsmiths College, University of London. His research field is black studies, with a focus on the intersections between black diasporic culture and black intellectual thought.

KYLE DEVINE is an Associate Professor in the Department of Musicology at the University of Oslo, and a research associate with the Music and Digitization Research Group at the University of Oxford. His work on music, sound and technology has appeared in *Popular Music* and *Popular Music History*, and his books include *Decomposed: The Political Ecology of Music* (MIT Press, forthcoming), *Living Stereo: Histories and Cultures of Multichannel Sound* (Bloomsbury 2015) and *The Routledge Reader on the Sociology of Music* (Routledge 2015).

URI DORCHIN has a PhD in anthropology. His work focuses on the meaning of popular music and its relevance to contemporary trends in Israeli society. He is the author of *Real Time: Hip-Hop in Israel/Israeli Hip-Hop* (Resling, 2012), a monograph that examines a set of questions pertaining to culture and art criticism via the test case of the appropriation of 'black music' by Israelis. Dorchin is currently a senior lecturer at Zefat Academic College in Israel.

ANDREW GREEN is a PhD candidate at the Department of Music, Royal Holloway, University of London. His research interests are in popular music, politics and social movements; his current research is focused on Mexico.

CHENJERAI KUMANYIKA is an artist, activist and Assistant Professor in Clemson University's Department of Communication Studies. Before his career in academia, Dr Kumanyika was the front man for the rap group The Spooks. In addition to his scholarly work, he is a board member of Street Poets and several youth mentoring programmes, a news analyst for Uprising Radio, and an amateur podcast producer.

JOHN R. PALMER is Associate Professor of Music at Sonoma State University, where he teaches musicology and directs an experimental rock ensemble. His areas of research include the music of Gustav Mahler, Beethoven, and Yes, and the intersection of music and the broader culture.
