## Part 2: Minutes of Meetings of the Federal Open Market Committee

The Federal Open Market Committee has been called "the most powerful group of private citizens in America." It administers the single most powerful weapon of modern monetary policy—controlling the supply of high-powered (reserves) money that underlies the nation's supply of money.

#### ---Paul A. Samuelson's Economics

The Federal Open Market Committee (FOMC) is the Federal Reserve System's most visible policy-making unit. Created to centralize the control of the Federal Reserve's open market operations, the FOMC consists of twelve members—the seven members of the Board of Governors and the presidents of five of the twelve district banks.

The FOMC determines the policy concerning the purchase and sale of government securities. Purchases of government securities by the Federal Reserve have an expansionary effect on the money supply; sales, a contractionary effect. Whether there is a national trend toward easy credit or tight credit, whether interest rates are high or low, whether there is a favorable financial climate for businesses to invest and expand or an adverse climate which fosters reduced production, the activities of the FOMC help to determine these conditions and many others.

The publication of *Minutes of Meetings of the Federal Open Market Committee* gives researchers their first complete record of the FOMC in action. The frank discussions of the FOMC on national and international economic and financial developments, on political pressures versus fiscal realities, and on a wide range of other crucial issues are available in their entirety only in this publication. It is an opportunity which researchers have eagerly awaited.

# PAPERS OF THE FEDERAL RESERVE SYSTEM

As the central bank of the United States, the Federal Reserve System formulates and administers policy for the nation's monetary and credit affairs. The Fed (as it is commonly called) is thus the nation's key financial institution, with the power to transfer funds, to handle government deposits and debt issues, to supervise and regulate banks, and to act as lender of last resort. Despite the pre-eminent position of the Fed in monetary and economic matters, no research collection has ever been published which aims to document the rise of the Fed to power and its continuing influence over the national economy. A new series, *Papers of the Federal Reserve System*, fills this void and marks the initial publication of thousands of pages of the Fed's records.

## Part 1: Legislation, Major Speeches and Essays, and Special Reports

The Federal Reserve System was established pursuant to authority contained in the Federal Reserve Act of 1913. *Part 1* of *Papers of the Federal Reserve System* publishes the legislative documents—bills, acts, hearings, and reports—which pertain to the evolution of the Fed's power. *Part 1* also publishes important speeches and essays by members of the Board of Governors of the Federal Reserve System and by high-level staff members. Finally, *Part 1* publishes many significant reports which the staff of the Fed has written on financial developments and crises throughout the years. Together, these materials form a valuable documentary record of the Federal Reserve System.

## Newcomen Awards in Business History

For the best article published in the *Business History Review* during the previous year the Society will award a prize of \$300 and a scroll. For the best article published in the *Business History Review* during the previous year by a graduate student or a recent Ph.D. who has not published a book in business history, the Society will award a special prize of \$150 and a scroll. Criteria for selection include: originality, value, breadth, and interest of contribution, quality of research materials and methods, and quality of presentation.

Winners will be selected by a panel of judges consisting of the editors and the members of the editorial board of the *Business History Review*, none of whom shall be eligible to receive a prize. The awards are administered by the editorial office of the *Review*. No special prize will be awarded in years when, in the opinion of the judges, no eligible article suitable for the prize was published, and no person may be awarded both prizes in any one year.



## **Thomas Newcomen Book Award in Business History**

The Newcomen Society of the United States, in cooperation with the Business History Reciew, will award in 1985 the eighth in a series of triennial prizes consisting of \$1000 and a scroll for the best book on the history of business published in the United States during the years 1982-1984. "Business history" is defined in its broadest sense to include not only the history of firms or industries, but books tracing interactions of businesses and businessmen to their economic, political, and social environments. Criteria for selection will include contribution to knowledge, depth of analysis, soundness of reasoning, clarity of style and organization, and general readability and format.

Judges for the 1985 award will be announced at an appropriate time by the Harvard Graduate School of Business Administration and the Newcomen Society of the United States.
